# **REGULATION OF VESSELS – EXCLUSION ZONE**

#### Location

The navigable waters of Budgewoi Lake at Budgewoi - in the area from Lake Entrance to Goorarabah and Buff Points and to the NSW Marine Rescue Clubhouse (formerly known as the Toukley Aquatic Club).

### Duration

9:00am to 5:00pm on the following dates:

- Round 1 Saturday, 11 & Sunday, 12 December 2021
- Round 2 Saturday, 15 & Sunday, 16 January 2022
- Round 3 Saturday, 29 & Sunday, 30 January 2022
- Round 4 Saturday, 5 & Sunday, 6 March 2022
- Round 5 Saturday, 21 & Sunday, 22 May 2022

# Detail

Competitive ski racing will be conducted on the waters of Budgewoi Lake at the location specified above. The event will involve the use of powered vessels, persons being towed at speed using towlines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of buoys, and control vessels stationed on the perimeter. There will also be support vessels present to manage the event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

Penalties may apply (section 12(5) - Marine Safety Act 1998)

# MINISTERIAL ORDER MADE UNDER SECTION 19

# Ministerial (Electric and Hydrogen Vehicle Transit Lane Exemption) Order 2021

I, Andrew Constance, Minister for Transport and Roads, pursuant to section 19(1) of the *Road Transport Act 2013* (NSW), make the following Order.

### 1. Name of Order

# This Order is the *Ministerial (Electric and Hydrogen Vehicle Transit Lane Exemption) Order 2021*

## 2. Commencement

This Order has effect on and from 1 November 2021 and remains in force up to and including 31 October 2022 unless revoked earlier.

### 3. Interpretation

Words and expressions used in this Order have the same meaning as in the *Road Transport Act 2013* unless otherwise stated.

### 4. Definitions

In this Order the following are defined:

battery electric vehicle means a motor vehicle that-

- (a) uses only an electric motor for propulsion, and
- (b) is not fitted with-
  - (i) a fuel cell, or
  - (ii) an internal combustion engine.

# hydrogen fuel cell electric vehicle means a motor vehicle that—

- (a) uses an electric motor for propulsion, and
- (b) is equipped with a fuel cell for converting hydrogen to electricity, and
- (c) is not fitted with an internal combustion engine.

# 5. Circumstances

This Order only applies to a driver of a **battery electric vehicle** or **hydrogen fuel cell electric vehicle** to which is affixed to the vehicle's number plate a label in accordance with clauses 144A or 144B of Schedule 2 of the Road Transport (Vehicle Registration) Regulation 2017.

# 6. Declaration

Road Rule 156 of the Road Rules 2014 is declared not to apply to drivers meeting the circumstances outlined in clause 5 of the Order.

# 7. Publication

The Order is to be published in the NSW Government Gazette.

# **Explanatory note:**

The object of this Order is to allow drivers of battery electric and hydrogen fuel cell motor vehicles to be driven in Transit Lanes, regardless of the number of passengers in the vehicle, subject to meeting certain circumstances in the Order.

This Order is made under section 19 of the Road Transport Act 2013.

# Declaration as Controlled Access Road, Declaration as Freeway and repeal as Controlled Access Road, of parts of the Pacific Highway at Tweed Heads West

I, the Minister for Regional Transport and Roads, by this order:

- 1. repeal the parts of the order published in Government Gazette No 82 of 6 May 1988 on page 2554 which declared the main road described in Schedule 1 of that declaration to be controlled access road but only in so far as these parts pertain to the land described in Schedule 1 hereunder; and
- 2. pursuant to Sections 46, 48, 49, 54 and 67 of the *Roads Act, 1993*:
  - a. dedicate as public road the land described in Schedules 2, 3 and 5 under;
  - b. declare to be a main road the said public road described in Schedules 3 and 5 and the public road described in Schedules 4 and 6 under;
  - c. declare to be a controlled access road the said main road described in Schedules 3 and 4 under;
  - d. declare to be a freeway the said main road described in Schedules 1, 5 and 6 under;
  - e. declare that access to the said controlled access road and freeway is restricted; and
  - f. specify in Schedule 7 under, the points along the controlled access road and freeway at which access may be gained to or from other public roads.
