ACTS OF PARLIAMENT ASSENTED TO Legislative Assembly Office, Sydney 1 November 2021

It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of Her Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 23 — An Act to amend various Acts, and to amend or repeal regulations, administered by the Minister for Better Regulation and Innovation; and for related purposes. **[Better Regulation Legislation Amendment (Miscellaneous) Bill]**

Act No. 24 — An Act to amend the Local Government Act 1993 to make further provision about the conduct of the 2021 local government elections. **[Local Government Amendment (COVID-19—Elections Special Provisions) Bill]**

Act No. 25 — An Act to provide for a system of distance-related road user charges for zero and low emissions vehicles and to amend the Duties Act 1997 to exempt certain zero and low emissions vehicles from the payment of duty under Chapter 9 of that Act. **[Electric Vehicles (Revenue Arrangements) Bill]**

Act No. 26 — An Act to amend the Water Industry Competition Act 2006 to make further provision about competition in the supply of water and the provision of sewerage services; to repeal the Water Industry Competition Amendment (Review) Act 2014; and for other purposes. **[Water Industry Competition Amendment Bill]**

Act No. 27 — An Act to amend the Coastal Management Act 2016 to defer the date on which certain provisions cease to have effect. **[Coastal Management Amendment Bill]**
