REGULATION OF VESSELS – EXCLUSION ZONE

Location

Wyangala Dam – adjacent to Wyangala Waters Holiday and Recreation Park

Duration

8.00am to 6.00pm on the following dates:

- Saturday 4 and Sunday 5 December 2021
- Saturday 5 and Sunday 6 February 2022
- Saturday 5 and Sunday 6 March 2022

Detail

A number of water-skiing races will be conducted on the navigable waters of Wyangala Dam at the dates and times specified above. The event will involve the use of high speed power vessels, persons being towed at speed using towlines and persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event, which will be marked by inflatable buoys and monitored by control vessels.


Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

MARINE NOTICE

Section 12(2)

REGULATION OF VESSELS – EXCLUSION ZONE

Location

Murray River – near the townships of Buronga and Gol Gol (NSW) between the 888km River Marker upstream to approximately 1 kilometre downstream of the 892km River Marker.

Duration

- 7:30am to 1:00pm – Sunday 5 December 2021

Detail

A water-ski training event will be conducted on the navigable waters of the Murray River involving the use of high speed power vessels during the date and time specified above. There will be support vessels present to manage the event, persons being towed at speed using tow-lines, and persons in the water from time to time – presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event at the respective locations for the entire width of the River.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be marked at each end by buoys, and official patrol and control vessels.

Vessels that are lawfully moored within the zone at the commencement time may remain in the zone but may not be operated other than under the direction of an authorised officer or event official. Such vessels may be required to be moved if safety concerns arise.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

REGULATION OF VESSELS – EXCLUSION ZONE AND SPECIAL RESTRICTIONS

Location

Sydney Harbour – Farm Cove to North Head

All navigable waters bounded by lines drawn between:

- Bennelong Point Port Beacon and Kirribilli Point
- the most northerly point of Middle Head and Cannae Point Flagstaff
- North Head Starboard Beacon and Hornby Light

Duration

12:00pm to 3:00pm – Tuesday 7 December 2021

Detail

The CYCA Grinders Coffee SOLAS Big Boat Challenge will be held at this time. The race starts near Point Piper and concludes at Farm Cove. Racing is between Sydney Heads and Fort Denison.

Exclusion Zone

An **EXCLUSION ZONE** is declared for the following areas to support safety of vessel operations during the event:

1. The area between two rows of yellow Exclusion Zone buoys laid to the North-West of Point Piper (the starting area) between 12:15pm and 12:45pm
2. The area extending 100m South-West of a line of yellow Exclusion Zone buoys laid to the North-West of Shark Island between 1:00pm and 2:30pm

The limits of the Exclusion Zone are as shown on the event map (see below for details).

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zones between the specified times, which will be patrolled by Transport for NSW vessels.

Penalties may apply (section 12(5) – *Marine Safety Act 1998*)

Special Restrictions

Operators of all vessels navigating within 200 metres of an active Exclusion Zone must:

- travel at a speed of less than 6 knots, and
- not create wash that may damage or impact unreasonably on vessels within the Exclusion Zone.

Penalties may apply (section 12(5) – *Marine Safety Act 1998*).
