



# Part 1 Preliminary

# 1. Name of Instrument

This Instrument is the Fisheries Management (Fishing Determination – Red Sea Urchin) Notification 2021.

# 2. Interpretation

In this Instrument:

red sea urchin means the species Heliocidaris tuberculata.

*sea urchin and turban shell restricted fishery* means the restricted fishery declared under Part 9, Division 1 of the Fisheries Management (General) Regulation 2019.

*TAC determination* has the same meaning as in section 40A of the Act.

the Act means the Fisheries Management Act 1994.

# 3. Notice of TAC determination for red sea urchin

(1) The TAC determination for red sea urchin in the sea urchin and turban shell restricted fishery for the fishing period 1 January 2022 to 31 December 2022, as

made by the TAF Committee under section 40D of the Act and clause 134 of the *Fisheries Management (General) Regulation 2019*, is 60 tonnes.

(2) This fishing determination has effect for the period 1 January 2022 to 31 December 2022.
