All navigable waters bounded by imaginary lines drawn between:

- Garden Island Port Hand Beacon and Bradley's Head Light
- the most northerly point of Middle Head, and Cannae Point Flagstaff,
- North Head starboard hand beacon and Macquarie Light

Detail and Special Restrictions

A special event will take place on Sydney Harbour at the above location, being the Rolex Sydney to Hobart Yacht Race 2021. Due to the potential to affect the safety of navigation, a **Regulated Area** with declared special restrictions will be established for the duration at the location specified above.

Pursuant to section 12(3) of the Marine Safety Act 1998, those restrictions are as follows:

- No sail vessel other than official competing yachts may have sails hoisted between 12:00pm and 2:00pm;
- The Regulated Area is declared a strict 6 knot speed limit zone and a "no wash" zone for the duration;
- Vessels intending to accompany or follow the racing fleet outside the heads are required to follow strict navigation channels leaving the Harbour in the vicinity of South Head and reentering via North Head, then using the Western Channel while keeping to the starboard side of the channel.
- Vessels intending to observe the event without leaving the Harbour are required to position their vessels on, and remain on, the western side of the Harbour or south of Vaucluse Point on the eastern side of the Regulated Area.

Exclusion Zone

In addition, an Exclusion Zone will be established within the Regulated Area between 12:00pm and 2:20pm, which will be marked by a perimeter of yellow buoys.

NO UNAUTHORISED VESSELS are to enter the Exclusion Zone, which will be patrolled by Transport for NSW (Maritime) patrol vessels, Water Police, and other official control vessels.

No Anchoring or Passive Craft Zone

Pursuant to section 12(3) of the *Marine Safety Act 1998, a* "No Anchoring or Passive Craft Zone" will also be established within the Regulated Area approximately 100m around the Exclusion Zone generally, extending to 200m from the Exclusion Zone in the Watsons Bay/Vaucluse Bay area, and extending to the whole of the area between the Exclusion Zone and North Head.

NO VESSELS are permitted to anchor in this area under any circumstances and, due to the safety risk posed by the event and by spectator vessel traffic, NO NON-POWERED PASSIVE CRAFT (e.g. canoes, kayaks, surf boats, surf skis, rowing craft) are permitted in this area at any time. Penalties apply (see below).

Offence provision

Any vessel operator

- contravening the Special Restrictions detailed above; or
- entering the Exclusion Zone; or
- contravening the "No Anchoring or Passive Craft Zone" rules detailed above

is liable to an offence (Marine Safety Act 1998, s.12(5) - Maximum Penalty \$1,100.00)



Detail and Special Restrictions

The annual New Years' Eve Fireworks and Lights On Parade - a Special Event on the waters of Sydney Harbour - will be taking place between the above times. Due to the potential to affect the safety of navigation, Transport for NSW (TfNSW) will establish a **Regulated Area** with declared special restrictions (including 'No Anchoring' and Exclusion Zones) in the location described above.

Pursuant to section 12(3) of the Marine Safety Act 1998, those special restrictions are as follows:

- (a) From 8:00am (31 Dec 2021) to 2:00am (1 Jan 2022), anchoring of vessels in the areas which will become the Exclusion Zone later in the evening (see below) is prohibited, and vessel operators must leave the "No Anchoring Zone" when directed;
- (b) From **8:00am** (31 Dec 2021) to **1:00am** (1 Jan 2022) Beulah Street and Jeffrey Street wharves, Kirribilli will be closed to all vessels;
- (c) From **10:00am** (31 Dec 2021) to **1:00am** (1 Jan 2022) McMahons Point ferry wharf will be closed to all vessels;
- (d) From **3:00pm** (31 December 2021) to **1:00am** (1 Jan 2022) Milsons Point ferry wharf will be closed to all vessels;
- (e) From **3:00pm** (31 Dec 2021) to **2:00am** (1 Jan 2022), a maximum speed limit of **6 knots** is declared in the Area (unless otherwise authorised by TfNSW or Police);
- (f) From **8:00pm** (31 Dec 201) to **2:00am** (1 Jan 2022), additional "No Anchoring Zones" are declared in the channels, between:
 - Balmain East and Goat Island
 - Balls Head and the Snails Bay dolphins

- Garden Island and Fort Denison; and
- off Bradleys Head.

The 'No Anchoring Zones' near Balls Head, Garden Island, and Bradleys Head will be marked by yellow 'no anchoring' buoys with quick flashing yellow lights.

Exclusion Zone

To safeguard the display and fireworks vessels, strict **Exclusion Zones** will be established inside the Area between **8:00pm** (31 Dec 2021) and **12:45am** (1 Jan 2022) which will be marked by perimeters of yellow lit buoys.

NO UNAUTHORISED VESSELS OR PERSONS are to enter Exclusion Zones under any circumstances, which will be patrolled by Police, TfNSW and other official control vessels.

The times stipulated above may be extended without notice by TfNSW in the interests of public safety. Entry of vessels or persons into Exclusion Zones renders the vessel operator or person liable to an offence.

Directions

TfNSW advises that in relation to the Regulated Area:

- 1) Persons **must** comply with any directions given by a TfNSW Boating Safety Officer or Police Officer in relation to the Special Event or to marine safety. Failure to comply with any such direction is an offence (*Marine Safety Act 1998 s.15A* Maximum Penalty \$3,300.00).
- 2) Any vessel operator or persons
 - breaching the Special Restrictions detailed above; or
 - entering Exclusion Zones; or
 - anchoring in the "No Anchoring Zone".



MINISTERIAL ORDER MADE UNDER SECTION 19

Ministerial (Bus and Transit Lane Exemption) Order 2021 No.3

I, Robert Gordon Stokes, Minister for Transport and Roads, pursuant to section 19(1) of the *Road Transport Act 2013* (NSW), make the following Order.

1 Name of Order

This Order is the Ministerial (Bus and Transit Lane Exemption) Order 2021 No 3.

2 Commencement

This Order has effect on and from the date of publication in the NSW Government Gazette.

3 Effect

This Order remains in force up to and including 30 June 2022 unless revoked earlier.

4 Interpretation

Words and expressions used in this Order have the same meaning as in the *Road Transport Act 2013* unless otherwise stated.

5 Application

This Order applies to a driver driving a *hire vehicle* (within the meaning of the *Point to Point Transport (Taxis and Hire Vehicles) Act 2016*) to which is affixed a HC numberplate issued by Transport for NSW while the vehicle is being used for the purpose of providing a passenger service under that Act.

6 Declaration

The following NSW Road Rules are declared not to apply:

- (a) Road Rule 154(1) driving in a Bus Lane other than a "Bus Only" or "Buses Only" lane.
- (b) Road Rule 156(1) driving in a Transit Lane.

7 Repeal of previous Order

The *Ministerial (Bus and Transit Lane Exemption) Order 2021 No.2* published in *NSW Government Gazette No 277 (Roads and Transport)* of 25 June 2021 on pages 4 to 5 is hereby repealed on and from the commencement of this Order.

8 Publication

The Order is to be published in the NSW Government Gazette.

Explanatory note:

The object of this Order is to continue an exemption for drivers of hire vehicles with a HC number-plate issued by Transport for NSW from restrictions on the use of bus lanes and transit lanes under the Road Rules 2014. It does not permit those drivers to drive in a bus only lane.

This Order is made under section 19 of the Road Transport Act 2013.

At various times during the event, control vessels may authorise local vessel traffic to transit the zone. Pursuant to section 12(3) of the Marine Safety Act 1998, all transiting vessels must not exceed 4 knots and must produce no wash.
