Section 109
Declaration of Mental Health Facility

I, MAUREEN LEWIS, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007* and section 43 of the *Interpretation Act 1987*, DO HEREBY:

a) REVOKE the Order published in the NSW Government Gazette No.666 of 24 December 2021 (n2021-2872), declaring inpatient units at the Maitland Hospital and the New Maitland Hospital to be declared mental health facilities, in accordance with section 109 of the *Mental Health Act 2007*; and

b) DECLARE the following premises to be declared as a mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:

MENTAL HEALTH ACT 2007
Section 109
Declaration of mental health facility

I, MAUREEN LEWIS, Acting Executive Director, Mental Health Branch, acting under delegation from the Secretary of the NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY:

(a) REVOKE the Order published in the NSW Government Gazette n2021-1458 of 9 July 2021, declaring certain premises of Bloomfield Hospital to be a mental health facility in accordance with section 109 of the *Mental Health Act 2007*; and

(b) DECLARE the following premises of **Bloomfield Hospital** to be a declared mental health facility for the purposes of section 109 of the *Mental Health Act 2007*:

Bloomfield Mental Health Service Centre, situated at Bloomfield Hospital Campus, Orange Health, Forest Road, Orange NSW 2800, comprising the following units and including areas between the units:

- **Adult Acute Unit**, Lachlan Building, located on The Avenue
- **Amaroo Unit**, located on Canobolas Drive
- **Castlereagh Unit**, Windamere Building, located on Canobolas Drive
- **Child and Adolescent Mental Health Unit**, General Hospital Building, located on The Avenue
- **Infant, Child, Youth and Family Unit**, Building 13, located on The Crescent
- **Macquarie Unit**, Windamere Building, located on Canobolas Drive
- **Manara Clinic**, located on Canobolas Drive
- **Mental Health Intensive Care Unit**, Lachlan Building, located on The Avenue
- **Older Persons Acute Unit**, Lachlan Building, located on The Avenue
- **Turon House**, located on Canobolas Drive
- **Wattle Grove**, located on Canobolas Drive; and

(c) DECLARE this facility to be designated in the class of facilities known as “mental health assessment and inpatient treatment” for the purposes of section 109(2)(a).
