It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of Her Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 1 — An Act to amend the Crimes (Administration of Sentences) Act 1999, the Crimes (High Risk Offenders) Act 2006 and other Acts in relation to the Victims Register and high risk offenders; and for related purposes. **[Crimes (Administration of Sentences) Amendment Bill]**

Act No. 2 — An Act to amend the Licensing and Registration (Uniform Procedures) Act 2002 to streamline procedures for certain licences, registrations and other authorisations and make provision for issuing digital licences; and to make consequential amendments to other legislation. **[Licensing and Registration (Uniform Procedures) Amendment Bill]**

Act No. 3 — An Act to amend environment protection legislation for particular purposes. **[Environment Legislation Amendment Bill]**
