REGULATION OF VESSELS - EXCLUSION ZONE

Location

Hawkesbury River – the entirety of the river between the following locations:

- A. From Windsor Bridge up to and including Sackville, and
- B. From Windsor Bridge up to and including Wiseman's Ferry.

Duration

- 8.00am to 5.00pm Saturday 26 March 2022 at Location A, and
- 8.00am to 5.00pm Sunday 27 March 2022 at Location B.

Detail

A high speed water ski race event will be held on the Hawkesbury in the locations specified above. Persons will be towed at speed using tow-lines with the possibility of persons in the water from time to time, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during each event at the relevant location.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone between the specified times.

REGULATION OF VESSELS - EXCLUSION ZONE

Location

Lake Jindabyne – near the township of Jindabyne, adjacent to Foreshore Park, extending approximately 600 metres into Lake Jindabyne and contained between the landmarks known as Widows Creek Lookout, Lion Island and Cub Island.

Duration

• 6.00am to 10.00am – Saturday 12 March 2022

Detail

The swim leg of a triathlon will be conducted on the navigable waters of Lake Jindabyne specified above.

An **EXCLUSION ZONE** is specified during the event and will be indicated by the presence of course rounding buoys and control vessels stationed on the boundary.

Unauthorised vessels and persons are strictly prohibited from entering the Exclusion Zone.
