DECLARATION OF PARK

I, SALLY GORDON THOMAS, Administrator of the Northern Territory of Australia, acting with the advice of the Executive Council:

- (a) under section 12(1)(a) of the *Territory Parks and Wildlife Conservation Act*, declare the area of land described in the Schedule to be a park; and
- (b) under section 12(1)(aa) of the *Act*, declare that all right, title and interest held by the Territory in respect of that land does not vest in the Corporation; and
- (c) under section 17(5) of the *Territory Parks and Wildlife Conservation Act*, approve the Commission performing its functions in the park declared by paragraph (a) for the purpose of operating the park while a plan of management is being prepared for the park.
