CHARGES FOR MEDICAL SERVICES

PART 1 MEDICAL SERVICES

- 1 This Part applies to a person receiving the medical service who is:
 - (a) an alien; or
 - (b) insured in respect of charges for the service.
- 2 The charges for medical services for a person to whom this Part applies are as set out in this Table.

Medical Service	Charge
In hours consultation with a general practitioner at the premises	\$140
In hours consultation with a nurse for dressings and review at the premises	\$70
Emergency service presentation consultation with remote area nurse (with or without phone assistance from a rural medical practitioner), whether or not at the premises	\$330 per hour
Emergency service presentation consultation with remote area nurse and resident general practitioner, whether or not at the premises	\$500 per hour

Any medical service:

- (a) for which a person is not eligible for a rebate under the Medicare Benefits Schedule; and
(for example: a work related medical examination, an assessment for eligibility for life insurance or an assessment for suitability to hold a pilot licence)
- (b) provided by a general practitioner or remote area nurse \$250

PART 2 TRANSPORT

1. This Part applies to a person receiving a medical service under Part 1 who is insured in respect of the charges.
2. If transport is provided or authorised under section 9 of the Act as part of a medical service, the charge for the medical service is increased by the amount set out in this Table.
