## Liquor Act

# DECLARATION OF GENERAL RESTRICTED AREA AND PUBLIC RESTRICTED AREAS

The Northern Territory Licensing Commission:

- (a) under section 84 of the *Liquor Act*, revokes the declaration of a general restricted area under section 74(1)(a) of the *Act* notice of which was published on pages 1 to 3 of *Gazette* S25 on 4 June 2008; and
- (b) under section 74(1)(a) of the *Liquor Act*, declares the area of land described in Schedule 1, but excluding the areas described in Schedule 2, to be a general restricted area; and
- (c) under section 86G of the *Liquor Act*, revokes the declaration of public restricted areas under section 86E(1)(a) of the *Act* notice of which was published on page 4 of *Gazette* S25 on 4 June 2008; and
- (c) under section 86E(1)(a) of the *Liquor Act*, declare each area described in Schedule 2 to be a public restricted area.

This instrument takes effect on 1 October 2011.

- then west along latitude 12° 15' S to the left bank of the Muralidbar Creek;
- then generally northeasterly along the left banks of the Muralidbar Creek and the Liverpool River to longitude 134° 8' E;

- then north along longitude 134° 8' E to latitude 12° S;
- then west along latitude 12° S to longitude 133° E;
- then south along longitude 133° E to latitude 12° 2' 15" S;
- then west along latitude 12° 2' 15" S to the left bank of Cooper Creek;
- then generally westerly, southerly and southeasterly along the left bank of Cooper Creek and the right bank of East Alligator River to the starting point.

# (b) Excluded area

Special Mineral Lease (SML) No. 94 and the area adjacent to SML 94 bounded by a line described as follows

- starting at the most western southwestern corner of SML 94;
- then west along the westerly prolongation of the southern boundary of SML 94 for 1km;
- then north along a straight line to its intersection with the westerly prolongation of the northern boundary of SML 94;
- then east along that prolongation to the boundary of SML 94;
- then southwesterly, westerly and southerly along the northwestern, northern and western boundaries of SML 94 to the starting point.

# Port Keats

All that area of land shown cross-hatched on the following map. Where the boundary of that area is a coastline, the boundary is the low water mark of that coastline.
