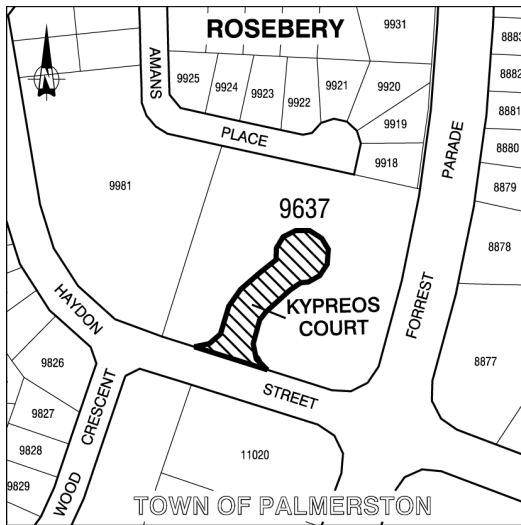

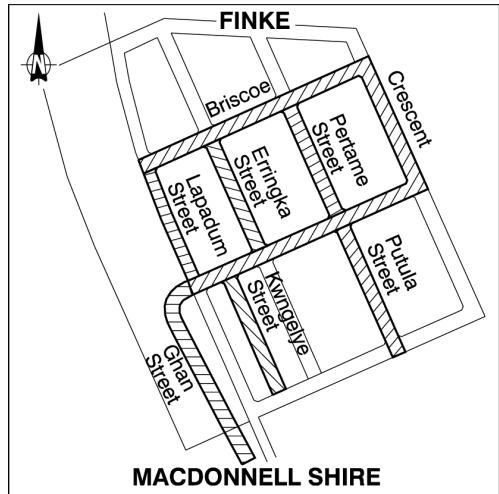

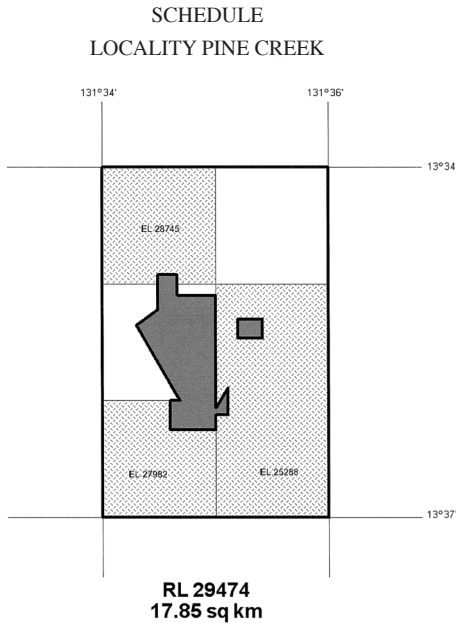
GENERAL RESERVATION OF LAND (RL 29474)

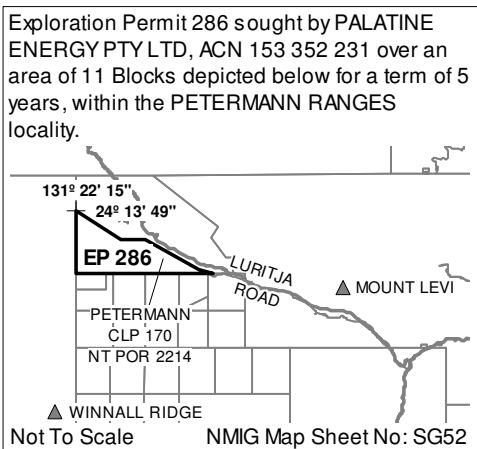
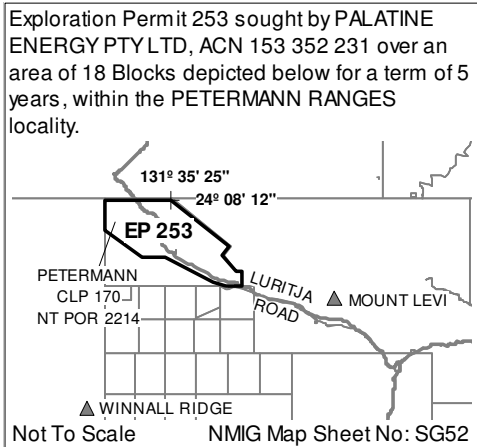
