Local Government Act CHANGE OF WARD BOUNDARIES

I, MALARNDIRRI BARBARA ANNE McCARTHY, Minister for Local Government, under section 9(2) of the *Local Government Act*, and with reference to section 9(1)(g) of that *Act* and section 42(1) of the *Interpretation Act*:

- (a) change the boundaries of Nyirranggulung ward and Never Never ward, within the Roper Gulf Shire, by removing from Nyirranggulung ward and adding to Never Never ward the area cross-hatched on Compiled Plan CP 5408; and
- (b) make that change for the purpose of conducting the election to be held on 24 March 2012 and determining the boundaries of Nyirranggulung ward and Never Never ward after that election.

- (a) change the number of members to be elected for Timber Creek ward, within the Victoria Daly Shire, from 2 members to 1 member; and
- (b) make that change for the purpose of conducting the election to be held on 24 March 2012 and the constitution of the Council after that election.

CREATION OF ADDITIONAL WARD - BARKLY SHIRE


I, MALARNDIRRI BARBARA ANNE McCARTHY, Minister for Local Government, under section 9(2) of the *Local Government Act* and:

Local Government Act CREATION OF ADDITIONAL WARDS -EAST ARNHEM SHIRE

I, MALARNDIRRI BARBARA ANNE McCARTHY, Minister for Local Government, under section 9(2) of the *Local Government Act* and:

- (a) with reference to section 9(1)(f) of the *Act*, create 2 new wards in the East Arnhem Shire; and
- (b) with reference to section 9(1)(h) of the *Act*, assign the names Birr Rawarrang and Gumurr Miyarrka to the new wards; and
- (c) with reference to section 9(1)(g) of the *Act*, define the boundaries of Birr Rawarrang ward and Gumurr


Miyarrka ward and change the boundaries of Gumurr Gattjirrk ward and Gumurr Miwatj ward to those shown on Compiled Plan CP 5401 in the Schedule; and

- (d) with reference to section 9(1)(i) of the Act:
 - determine the number of members to be elected for Birr Rawarrang ward and Gumurr Miyarrka ward to be 2 members for each ward; and
 - change the number of members to be elected for each of Anindilyakwa ward and Gumurr Gattjirrk ward from 3 members to 2 members.
