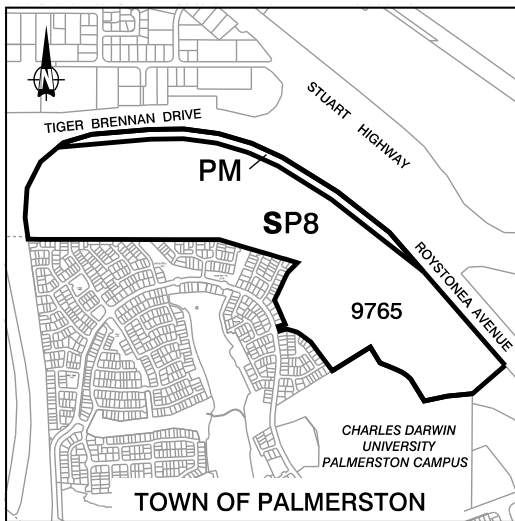

REASONS FOR DETERMINATION  
EDP12/0001

The application by MasterPlan NT for an Exceptional Development Permit to allow the development of Section 2257 (120) Challoner Circuit, Hundred of Strangways for additions and alterations to an existing transport terminal (bus depot) in two stages is granted pursuant to Section 40(3)(a) of the *Planning Act* for the following reasons:

1. Pursuant to section 40(1) of the *Act*, it is preferable to issue an Exceptional Development Permit than to amend the NT Planning Scheme as the instrument will restrict the use of the land to that consistent with the existing land use and retain a high compatibility with the surrounding rural living and community purpose land.
2. The use of the land as a transport terminal has been in existence since 1989 and the proposal seeks to improve and modernise the existing facilities and formalise the site layout.
3. The character and amenity of the locality is not likely to be significantly affected. The proposed additions and alterations provide adequate landscaping and car parking, improved facilities and access, and a formalised site layout.
