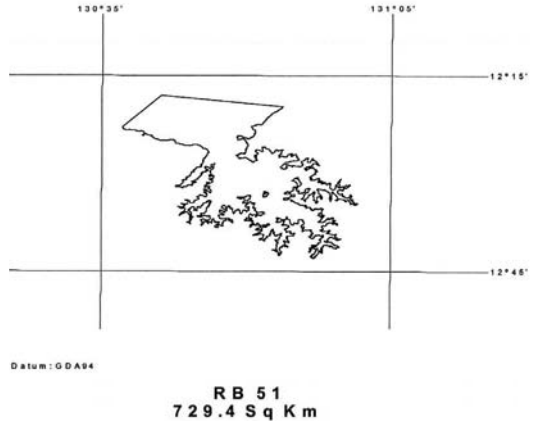

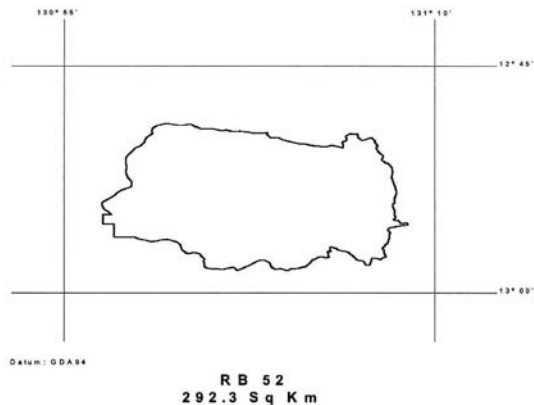

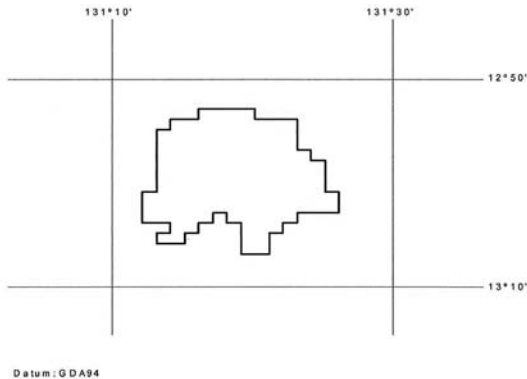

WATER MIMOSA

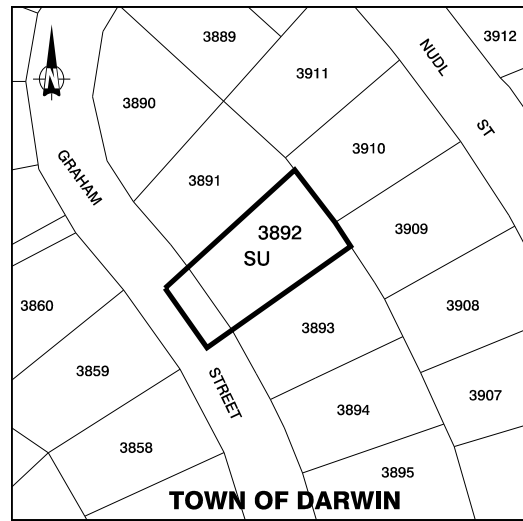
