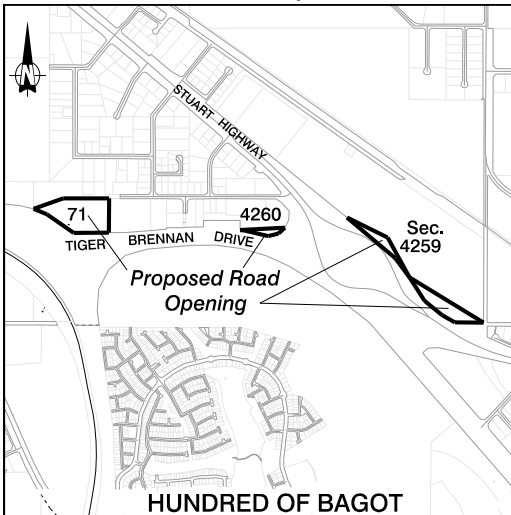
PROPOSAL TO OPEN ROAD

NAMING OF PLACE

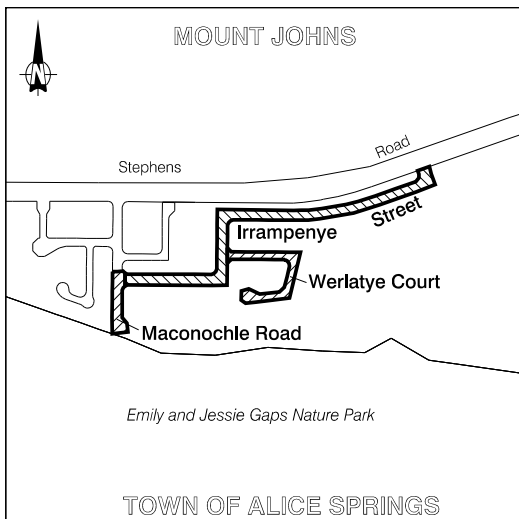

Note:

- Irrampenye Street named after one of the Traditional Owners of Alice Springs (male), born in the region of the Old Telegraph Station in the mid 1800's (pronounced irr-ram-pen-ya).
- Werlatye Court named after one of the Traditional Owners of Alice Springs (female), born in the region of the Old Telegraph Station in the mid 1800's (pronounced wool-at-ya).
- Maconochie Road named after John Maconochie who, at the time of his death, had been the longest serving Botanist in the NT, employed continuously in Alice Springs from 1967 to 1984.
