- updating clause 1.3 to state that the construction, alteration, repair or maintenance of fibre ready infrastructure is not prevented, so long as proposed clause 13.7 (Provision of Fibre Ready Infrastructure) has been complied with;
 - inserting a new reference note next to each relevant zone and performance criteria advising that proposed clause 13.7 refers to the provision of fibre ready infrastructure; and
 - introducing proposed clause 13.7, which requires that broadacre and infill development provide fibre-ready trenching and ducting.

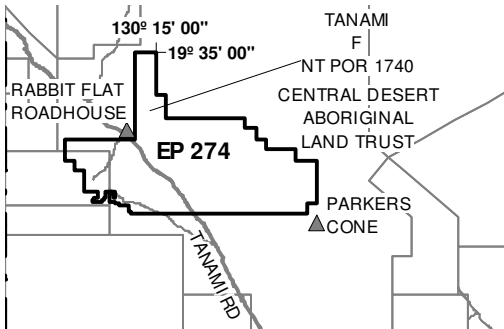

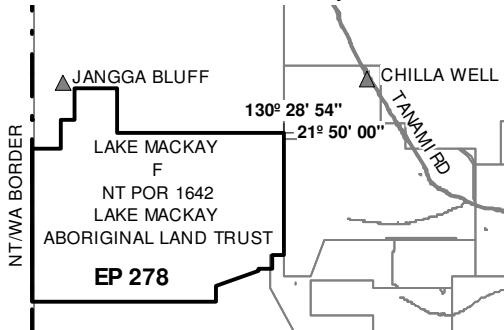

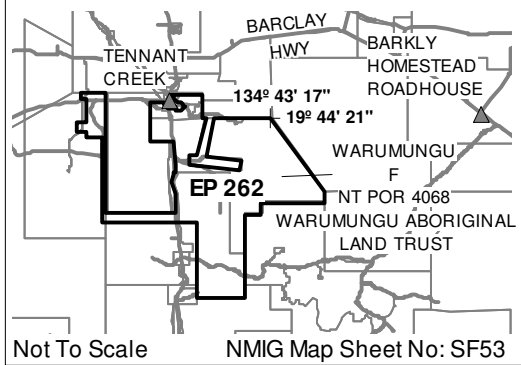

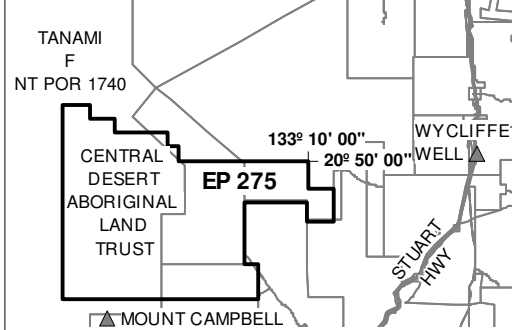

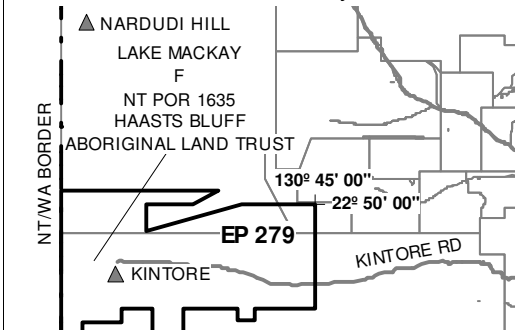

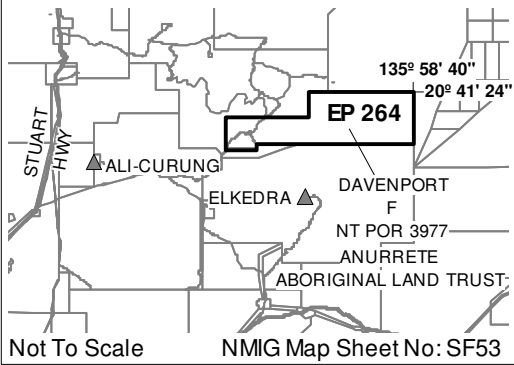

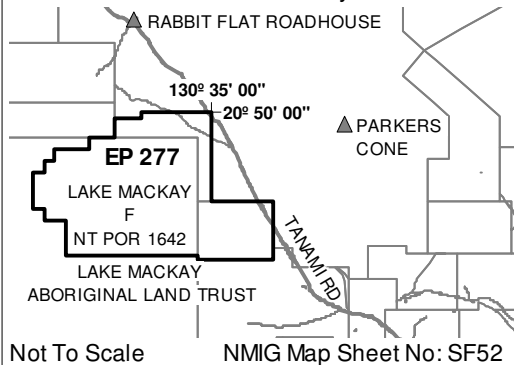

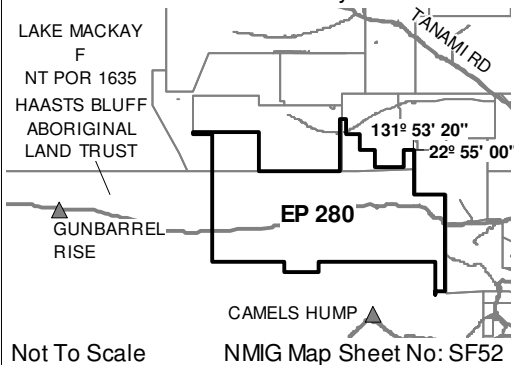
