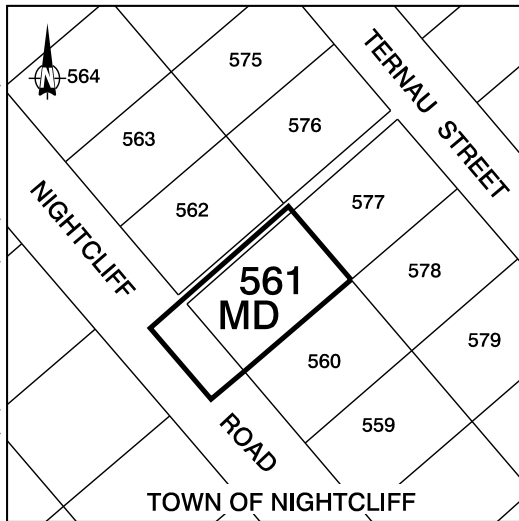

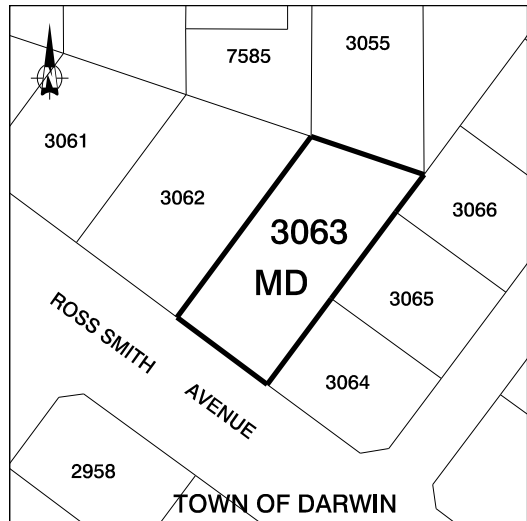

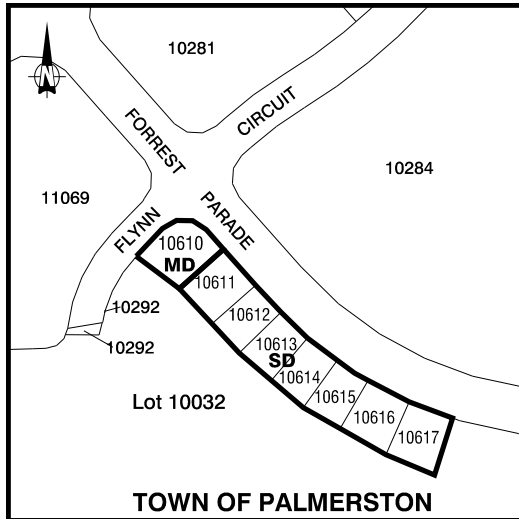

DETERMINATION OF CLASSIFICATIONS OF PROPERTIES CATTLE TICKS (PARKHURST AND ULTIMO STRAINS)

I, MALCOLM LAURENCE ANDERSON, Chief Inspector:

- (a) under section 46 of the *Livestock Act* and with reference to section 43 of the *Interpretation Act*, revoke the following instruments:
 - (i) "Determination of Classifications of Properties Cattle Ticks (Parkhurst Strain)" dated 17 June 2009 and published in *Gazette* No. G25 of 24 June 2009;
 - (ii) "Determination of Classifications of Properties Cattle Ticks (Ultimo Strain)" dated 13 May 2010 and published in *Gazette* No. G20 of 19 May 2010; and
- (b) under section 46 of the *Livestock Act*, determine that:
 - (i) a classification specified in the Schedule, column 1, may be given to a property in relation to either of the following notifiable diseases:

- (A) cattle ticks (Ultimo strain) ;
- (B) cattle ticks (Parkhurst strain); and
- (ii) for cattle ticks (Ultimo strain), the circumstance specified in the Schedule, column 2, opposite a classification must apply in relation to a property before it may be given that classification; and
- (iii) for cattle ticks (Parkhurst strain), the circumstance specified in the Schedule, column 3, opposite a classification must apply in relation to a property before it may be given that classification.
