### Planning Act

#### PROPOSED EXCEPTIONAL DEVELOPMENT PERMIT

I, PETER GLEN CHANDLER, the Minister for Lands, Planning and the Environment, determine pursuant to section 17 of the *Planning Act*: that:

- (a) a proposed Exceptional Development Permit, as described in (e), is to be exhibited;
- (b) the proposal is to be exhibited at the following locations: Offices of the Department of Lands, Planning and the Environment, Ground Floor, Arnhemica House, 16 Parap Road, Parap NT 0820; and
- (c) I have determined, pursuant to section 15(1), that the proposal is to be exhibited for a period of 28 days, commencing upon first newspaper publication of the notice required by section 17(1);
- (d) written submissions in respect of this exhibition should be made to:

(e) the proposed Exceptional Development Permit is to allow the use and development of sections 3876 and 3877 (1290 and 1300) Stuart Highway, Hundred of Strangways for the purpose of a transport terminal including office areas, caretaker's residence and stockpiling of materials. The land is in Zone RL (Rural Living) of the Northern Territory Planning Scheme, and the use of the site for the proposed purpose would otherwise be prohibited in this zone.

### Control of Roads Act


#### ORDER TO CLOSE PART OF ROAD
