SCHEDULE

REGISTRAR-GENERAL'S DIRECTIONS: GENERAL MATIERS

1 Approved forms

An approved form is a form published in the document entitled "Land Titles Office Forms" kept at the Land Titles Office and available on the website of the Land Titles Office.

- 2 Requirements relating to lodgment of approved form
 - (1) An approved form must be printed on paper that:
 - (a) is of International Paper size A4; and
 - (b) has a weight of 80 gsm; and
 - (c) is white; and
 - (d) is not transparent.
 - (2) A person who lodges an approved form must comply with the notes on the form.

3 Waiver of requirement for transferee to execute transfer

For section 61(3)(a) of the *Act*, in each case where a lot is transferred to the Territory, the Registrar-General may waive the requirement that the transfer be executed by the transferee.

4 Witness to execution of instrument by natural person

- (1) For section 159(2)(b) of the *Act* and Schedule 1 to the *Act*, the following persons are approved to witness the execution of an instrument by a natural person:
 - (a) if the place of execution is in the Northern Territory - a person specified in Annexure A;
 - (b) if the place of execution is in a State, Territory or place within Australia - a person who holds an office specified in Annexure B in a State, Territory or place of execution;
 - (c) if the place of execution is in a place outside Australia that is a member of the Commonwealth of Nations - a person specified in Annexure C; or
 - (d) if the place of execution is any other place outside Australia - a person specified in Annexure D.

Note for subclause (1)(a)

Schedule 1 to the Act also specifies certain classes of persons who may witness the execution of an instrument by a natural person in the Northern Territory.

(2) In addition to complying with section 160 of the Act, a person who witnesses the execution of an instrument by a natural person must write on the instrument the person's full name and qualification as witness.




