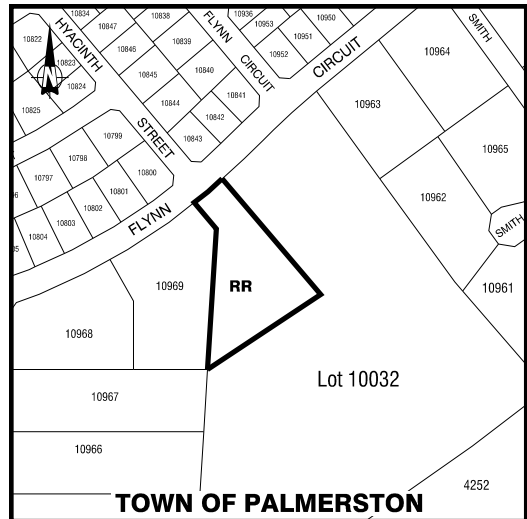

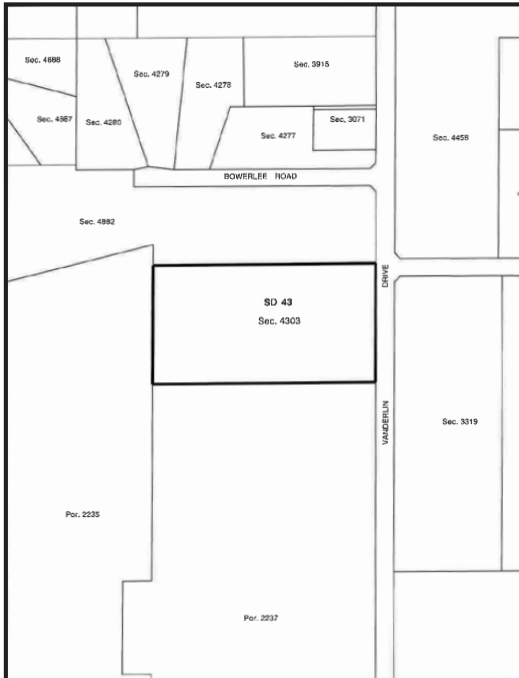

GENERAL RESERVATION OF LAND ON CESSATION OF TITLE (RL 29788)

I, ANNETTE LORRAINE DUNCAN, Director Mineral Titles, as delegate of the Minister for Mines and Energy, under section 114 of the *Mineral Titles Act*:

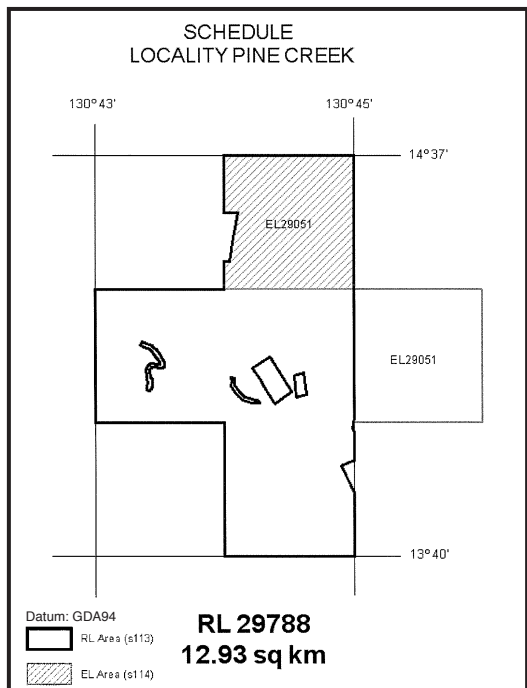
(a) under section 114 of the *Mineral Titles Act*, and with reference to section 43 of the *Interpretation Act*, revoke the instrument entitled "General Reservation of Land on Cessation of Title (RL29788)" dated 12 February 2013, and published in *Gazette* No. G9 of 27 February 2013; and

(b) under section 114 of the *Mineral Titles Act*, state that the land in the title area of the part of EL 29051 shown hatched within the thick black lines on the plan in the Schedule will become general reserved land on the day EL 29051 ceases to be in force, which will be 5 June 2015 unless the EL is sooner cancelled or surrendered or is renewed; and

- (c) under section 114 of the *Act*, give notice that:
- (i) the land mentioned in paragraph (b) is reserved from the following activities:
 - (A) exploration for minerals generally;
 - (B) extraction of minerals generally;
 - (C) exploration for extractive minerals;
 - (D) extraction of extractive minerals; and
 - (ii) the land is being reserved to enable the Department of Mines and Energy to conduct a geological review of the land to determine the existence of minerals suitable for fossicking and the viability of the land for inclusion in a fossicking area; and
 - (iii) a person is not entitled to apply for the grant of any mineral title in relation to the land.

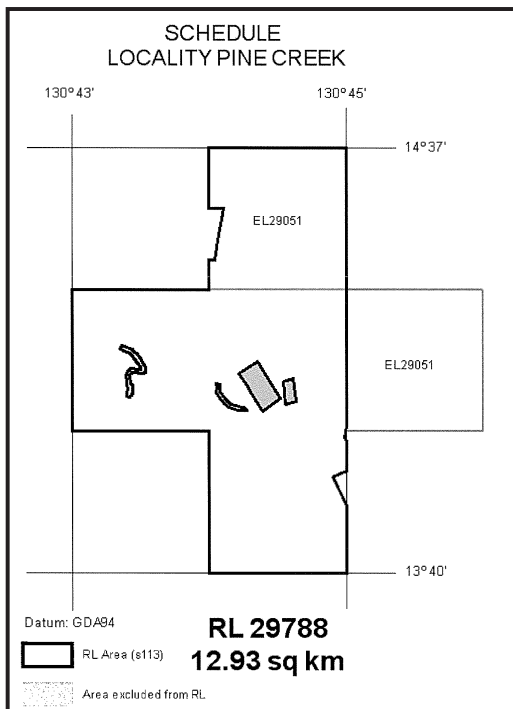
Mineral Titles Act**GENERAL RESERVATION OF LAND (RL 29788)**

I, ANNETTE LORRAINE DUNCAN, Director Mineral Titles, as delegate of the Minister for Mines and Energy:

- (a) under section 113 of the *Mineral Titles Act*, and with reference to section 43 of the *Interpretation Act*, revoke the instrument entitled "General Reservation of Land (RL 29788)" dated 12 February 2013, and published in *Gazette* No. G9 of 27 February 2013; and
- (b) under section 113 of the *Mineral Titles Act*, reserve the land that is shown unshaded within the thick black lines on the plan in the Schedule from the following activities:
 - (i) exploration for extraction minerals;
 - (ii) extraction of extractive minerals; and
- (c) under section 113 of the *Act*, give notice
 - (i) that: the reservation will take effect on the day this notice is published in the *Gazette*; and
 - (ii) the land is being reserved to enable the Department of Mines and Energy to conduct a geological review of the land to determine the existence of minerals suitable for fossicking and the viability of the land for inclusion in a fossicking area; and
 - (iii) a person is not entitled to apply for the grant of any mineral title in relation to the land.

**Territory Parks and Wildlife Conservation Act****DECLARATION**

I, MATTHEW ESCOTT CONLAN, Minister for Parks and Wildlife, under section 45(1) of the *Territory Parks and Wildlife Conservation Act* and with reference to section 45(2) of the *Act*, declare that it is lawful to kill animals of a species of protected wildlife specified in Schedule 1 or 2, subject to the following conditions:

- (a) the animals may be killed only during the period from 18 September 2013 to 5 January 2014 and between the following times on each day during that period:
 - (i) 6.15am to 7.00pm in September;
 - (ii) 6.00am to 7.00pm in October;
 - (iii) 5.45am to 7.15pm in November;
 - (iv) 5.45am to 7.30pm in December;
 - (v) 6.00am to 7.45pm in January;
- (b) the areas within which the animals may be killed are all areas of the Territory except the following:
 - (i) a park, reserve, sanctuary, protected area or wilderness zone under the *Act*;
 - (ii) any area where, under a law in force in the Territory, the discharging of a firearm, as defined in the *Firearms Act*, is prohibited;
- (c) the following type of equipment is to be used to kill the animals specified in Schedule 1:
 - (i) a shotgun of not more than size 10 gauge and not less than size 20 gauge;
 - (ii) shot cartridges:
 - (A) of type non-toxic shot (excluding shot cartridges containing lead, coated lead or zinc shot); and
 - (B) of shot size not more than BBB for all cartridges and not less than No 2 if the cartridges are steel shot and not less than No 4 if the cartridges are other than steel shot;
 - (iii) a bow (excluding a crossbow);
- (d) the following type of equipment is to be used to kill the animals specified in Schedule 2:
 - (i) a shotgun of not more than size 10 gauge and not less than size 20 gauge;
 - (ii) shot cartridges:
 - (A) of type non-toxic shot (excluding shot cartridges containing lead, coated lead or zinc shot); and
 - (B) of shot size not more than BB and not less than No 6 if the cartridges are steel shot and not more than No 1 and not less than No 6 if the cartridges are other than steel shot;
 - (iii) a bow (excluding a crossbow);
- (e) the maximum number of animals a person may kill in one day is:
 - (i) 10 of the animals specified in Schedule 1; and
 - (ii) a total of 10 of the animals specified in Schedule 2;
- (f) the maximum number of dead animals or parts of dead animals a person may have in his or her possession or under his or her control is:

- (i) away from the person's place of residence - 30 of the animals specified in Schedule 1 and a total of 30 of the animals specified in Schedule 2: and
- (ii) at the person's place of residence - unlimited;
- (g) a person wishing to kill the animals cannot do so unless he or she has been granted a permit to do so or is a nominee under a permit granted to another person to do so;
- (h) a person:
 - (i) must not sell, barter, dispose of or exchange the dead animals or parts of the dead animals; and
 - (ii) must not kill the animals except for human consumption; and
 - (iii) must, if requested to do so by a conservation officer, provide information to the officer as to where and when an animal was shot; and
 - (iv) may use decoys and retriever dogs.

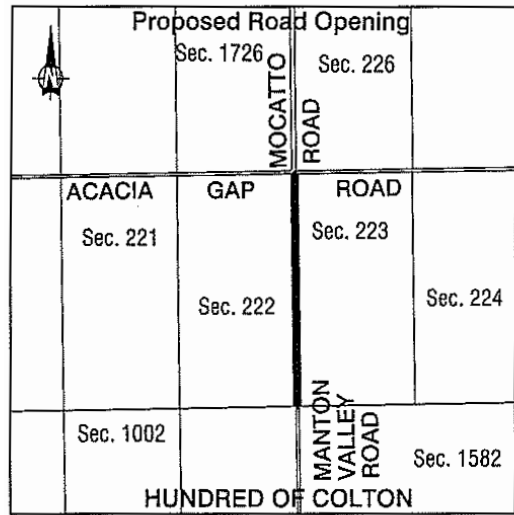
