Release of Information under Section 61(8)


## General Reservation of Land (RL 31445)

- I, Alan Charles Holland, Senior Director Mines/Director Mineral Titles, as the delegate of the Minister for Primary Industry and Resources, under section 113(2) of the *Mineral Titles Act*:
- (a) reserve the land in the Bynoe locality that is shown unshaded within the thick black line on the plan in the Schedule from the following activities:
  - (i) exploration for minerals generally;
  - (ii) extraction of minerals generally;
  - (iii) exploration for extractive minerals;
  - (iv) extraction of extractive minerals; and
- (b) give notice that:
  - (i) the reservation takes effect on the day this notice is published in the Gazette; and
  - (ii) the land specified in paragraph (a) is being reserved to enable the Power and Water Corporation to protect the catchment around the Darwin River Dam and Manton Dam; and
  - (iii) a person is not entitled to apply for the grant of any mineral title in relation to the land.




