Mineral Titles Act


General Reservation of Land (RL 31988)

- I, Armando Valentino Padovan, Executive Director Mines, Department of Primary Industry and Resources, as the delegate of the Minister for Primary Industry and Resources:
- (a) under section 113 of the *Mineral Titles Act*, reserve all the land in the locality of Bynoe that is shown within the thick black lines on the plan in the Schedule from the following activities:
 - (i) exploration for, and extraction of, minerals generally;
 - (ii) exploration for, and extraction of, extractive minerals; and
- (b) give notice that:
 - (i) the reservation mentioned in paragraph (a) takes effect on the day this notice is published in the *Gazette*; and
 - (ii) the land mentioned in paragraph (a) is being reserved for a proposed prawn breeding facility area; and
 - (iii) a person is not entitled to apply for the grant of any mineral title in relation to the land.
