Revocation and Appointment of Additional Public Holidays

I, Gerald Francis McCarthy, Minister for Public Employment:

- (a) under section 6 of the *Public Holidays Act 1981* and with reference to section 43 of the *Interpretation Act 1978*, revoke the appointment of additional public holidays made by instrument titled "Additional Public Holidays" dated 22 May 2017 and published in *Gazette* No. G23 of 7 June 2017; and
- (b) under section 6 of the *Public Holidays Act 1981*, appoint each of the following days to be a public holiday to be observed in each specified part of the Territory by all sections of the community in that part of the Territory:
 - (i) for the part of the Territory described in Schedule 1 Friday 24 July 2020 (Darwin Regional Show Day);

Schedule 1

All that parcel of land in the Northern Territory of Australia described as follows:

the part of the Northern Territory of Australia north of the parallel of south latitude 13 degrees 34 minutes and of the parts of the Northern Territory of Australia being the whole of the Anindilyakwa area described in Schedule 6 to the *Aboriginal Land Rights (Northern Territory) Act 1976* (Cth) and the whole of the Daly River area described in Schedule 1, Part 1 to that Act.

All that parcel of land in the Northern Territory of Australia bounded by lines described as follows:

commencing at the intersection of the parallel of south latitude 13 degrees 34 minutes with the sea coast of the Gulf of Carpentaria; thence generally southerly and south-easterly by the said sea coast to intersect the parallel of south latitude 15 degrees 30 minutes; thence west by the said parallel to intersect the meridian of east longitude 135 degrees; thence south by the said meridian to intersect the easterly prolongation of the northern boundary of Northern Territory Portion 2845; thence westerly by the said prolongation, the northern boundary of Northern Territory Portion 2845 and part of the northern boundary of Perpetual Pastoral Lease 1003 (Cattle Creek) to intersect the meridian of east longitude 132 degrees; thence south by the said meridian to intersect the easterly prolongation of the northern boundary of Pastoral Lease 826 (Suplejack); thence westerly by the said prolongation, the northern boundary of Pastoral Lease 826 and its westerly prolongation to intersect the meridian of east longitude 129 degrees being Northern Territory and Western Australia border; thence north by the said meridian to intersect the sea coast of the Timor Sea; thence generally easterly by the said sea coast to intersect the left bank of the Fitzmaurice River; thence generally easterly by the said left bank to intersect the southerly prolongation of the most easterly boundary of Northern Territory Portion 1637; thence northerly, westerly and again northerly by the said prolongation, an eastern, a northern and an eastern boundary of the said Portion to intersect the parallel of south point of commencement, thence easterly by the said parallel to the point of commencement, and including all Northern Territory of Australia coastal islands between the parallels of south latitude 13 degrees 34 minutes and 15 degrees 30 minutes, but excluding therefrom all islands within the Anindilyakwa area described in Schedule 6 to the Aboriginal Land Rights (Northern Territory) Act 1976 (Cth).

All that parcel of land in the Northern Territory of Australia bounded by lines described as follows:

commencing at the intersection of the parallel of south latitude 21 degrees 12 minutes with the meridian of east longitude 138 degrees being a point on the Northern Territory and Queensland border; thence south by the said meridian to intersect parallel of south latitude 26 degrees being the south-eastern corner of the Northern Territory; thence west by the said parallel to intersect meridian of east longitude 129 degrees being the south-western corner of the Northern Territory; thence south-western corner of the Northern Territory; thence north by the said meridian to intersect the westerly prolongation of the northern boundary of Pastoral Lease 826 (Supplejack); thence easterly by the said prolongation, the northern boundary of Pastoral Lease 826 and its prolongation easterly to intersect meridian of east longitude 132 degrees; thence south by the said meridian to intersect parallel of south latitude 21 degrees 12 minutes; thence east by the said parallel to the point of commencement.

Schedule 5

Revocation of Declarations and Declaration of Zones for Control of Cattle Ticks

I, Paul Andrew Kirby, Minister for Primary Industry and Resources:

- (a) under section 58(1)(c) of the *Livestock Act 2008* and with reference to section 43 of the *Interpretation Act 1978*, revoke both of the following:
 - the declaration made by notice entitled "Declared Area Cattle Ticks (Rhipicephalus microplus) Parkhurst Strain" dated 9 May 2011 and published in *Gazette* No. G20 of 18 May 2011;
 - (ii) the declaration made by notice entitled "Declared Areas Cattle Ticks (Rhipicephalus microplus)" dated 26 October 2013 and published in *Gazette* No. G46 of 13 November 2013; and
- (b) under section 58(1)(c) of the *Livestock Act 2008*:
 - (i) for the control of the notifiable disease cattle ticks (Parkhurst strain), which is an endemic disease, declare the area of land described in Schedule 1 and shown stippled on the map in Schedule 3 to be the Parkhurst Infected Zone; and
 - (ii) for the control of the notifiable disease cattle ticks (*Rhipicephalus microplus* and *Rhipicephalus australis*) in tick free areas, which is an endemic disease, declare each area of land described in Schedule 2 to be the type of zone specified opposite the area.


Secondly, commencing at a point approximately 12 degrees 11 minutes 39 seconds south latitude, and 132 degrees 47 minutes 27 seconds longitude coinciding with the low water mark on the East Alligator River, then on a bearing of 66 degrees and 18 minutes for a distance of 11.62 km more or less then on a bearing of 66 degrees 59 minutes for a distance of 10.61 km more or less then on a bearing of 27 degrees 43 minutes for a distance of 3 km more or less to intersect with Cooper Creek then in an east and south direction along Cooper Creek to the Oenpelli/Maningrida Road then in a west and south-west direction along the centreline of the Oenpelli/Maningrida Road to the Arnhem Highway/Oenpelli Road to the eastern boundary of NT Portion 1662 (East Alligator River), then generally northerly and north-westerly by the eastern bank of the East Alligator River to the point of commencement.

Revocation of Restriction and Restriction of Livestock Movement for Control of Cattle Ticks (Parkhurst Strain)

- I, Susanne Elizabeth Fitzpatrick, Chief Inspector of Livestock:
- (a) under section 59(1) of the *Livestock Act 2008* and with reference to section 43 of the *Interpretation Act 1978*, revoke the restriction made by notice entitled "Declared Area Movement Restrictions Cattle Ticks (Rhipicephalus microplus) Parkhurst Strain" dated 31 May 2011 and published in *Gazette* No. G23 of 8 June 2011 (as amended); and
- (b) under section 59(1) of the *Livestock Act 2008*, restrict the movement of livestock as set out in the Schedule.

1 Definitions

In this Schedule:

certified solution means a solution of which a sample has been chemically analysed by a laboratory approved by the Chief Inspector and certified by the laboratory to be a sample of a registered acaricide of a registered strength.

live cattle tick means a cattle tick that shows obvious signs of movement or from which bodily fluids can be expressed.

Parkhurst Infected Zone means the area of land declared to be the Parkhurst Infected Zone by the declaration made under section 58(1) of the Act for the control of cattle ticks (Parkhurst strain) as in force from time to time.

registered means registered by the Australian Pesticides and Veterinary Medicines Authority continued in existence by section 6 of the *Agricultural and Veterinary Chemicals (Administration) Act 1992* (Cth).

restricted livestock means alpacas, banteng, bison, buffalo, camels, cattle, deer, goats, llamas and sheep.

2 Livestock unloaded taken to start new movement

If restricted livestock being moved from one place to another are unloaded before reaching their destination, the restrictions imposed by this notice apply separately to:

- (a) the movement from the starting place to the place of unloading; and
- (b) the movement from the place of unloading to the destination.

3 Requirement for inspection, treatment and movement permit

- (1) If restricted livestock in the Parkhurst Infected Zone are to be moved out of the Parkhurst Infected Zone, the owner of the livestock must ensure that the movement does not start unless:
 - (a) the livestock meet the clean inspection and supervised treatment requirements; and
 - (b) a declared area movement permit has been granted for the movement.
- (2) Subclause (1) does not apply if the movement is authorised under clause 5(3).
- (3) Despite subclause (1)(a), the Chief Inspector may authorise the movement if satisfied that it is appropriate to do so.

4 Clean inspection

- (1) The clean inspection requirement is met if an inspector, after inspecting all of the restricted livestock that are to be moved, declares that all of the livestock are free of live cattle ticks.
- (2) The inspection for cattle ticks is to be carried out on the same day as the supervised treatment, but before that treatment is carried out.

- (3) If an inspector finds live cattle ticks on any of the livestock to be moved, a further inspection is to be carried out on all of the livestock in accordance with subclause (2).
- (4) A further inspection under subclause (3) must not be carried out within 3 days after the previous inspection without the approval of the Chief Inspector.

5 Supervised treatment

- (1) The supervised treatment requirement is met if the livestock are treated in accordance with the requirements set out in the Table.
- (2) All supervised treatments must be carried out under the supervision of, and in the manner approved by, an inspector.
- (3) An inspector may authorise the movement of the livestock to a place outside the Parkhurst Infected Zone for the purpose of enabling the livestock to be given treatment by plunge dip.
- (4) A plunge dip treatment requirement is met if the livestock are fully immersed in a certified solution of Amitraz or a certified solution that was certified:
 - (a) for an export yard within the previous 30 days; or
 - (b) for other yards within the previous 60 days.
- (5) A spray dip treatment requirement is met if the livestock are thoroughly sprayed with Amitraz or a solution approved by an inspector.
- (6) A injectable macrocyclic lactone treatment requirement is met if:
 - (a) the livestock are treated with a registered injectable macrocyclic lactone; and
 - (b) the treatment is conducted at a registered premises as defined in section 1.05 of the *Export Control (Animals) Order 2004* (Cth).

- (a) under section 59(1) of the *Livestock Act 2008* and with reference to section 43 of the *Interpretation Act 1978*, revoke the restriction made by notice entitled "Declared Area Movement Restrictions Cattle Ticks (Rhipicephalus microplus)" dated 29 August 2012 and published in *Gazette* No. G36 of 5 September 2012 (as amended); and
- (b) under section 59(1) of the *Livestock Act 2008*, restrict the movement of livestock as set out in the Schedule.

1 Definitions

In this Schedule:

approved program means a property cattle tick management program approved in writing by the Chief Inspector.

at risk (high) property means a property in the Control Zone where cattle ticks are not known to occur, and that has, within the previous 12 months, been assessed by the Chief Inspector and determined as being at high risk of cattle ticks occurring on the property.

at risk (low) property means a property in the Control Zone where cattle ticks are not known to occur, and that has, within the previous 12 months, been assessed by the Chief Inspector and determined as being at low risk of cattle ticks occurring on the property.

Cattle Ticks Zones Declaration means the declaration made under section 58(1) of the Act for the control of cattle ticks (*Rhipicephalus microplus* and *Rhipicephalus australis*) in tick free areas as in force from time to time.

certified solution means a solution of which a sample has been chemically analysed by a laboratory approved by the Chief Inspector and certified by the laboratory to be a sample of a registered acaricide of a registered strength.

Control Zone means the area of land declared to be the Control Zone by the Cattle Ticks Zones Declaration.

Free Zone means the area of land declared to be the Free Zone by the Cattle Ticks Zones Declaration.

infected property means a property in the Control Zone where cattle ticks are known to occur, and that has, within the previous 12 months, been assessed by the Chief Inspector and determined as having cattle ticks occurring on the property.

Infected Zone means the area of land declared to be the Infected Zone by the Cattle Ticks Zones Declaration.

live cattle tick means a cattle tick that shows obvious signs of movement or from which bodily fluids can be expressed.

non-assessed property means a property in the Control Zone where cattle ticks are suspected to occur, where surveillance has not been completed.

registered means registered by the Australian Pesticides and Veterinary Medicines Authority continued in existence by section 6 of the *Agricultural and Veterinary Chemicals (Administration) Act 1992* (Cth).

restricted livestock means alpacas, banteng, bison, buffalo, camels, cattle, deer, goats, horses, llamas and sheep.

2 Livestock unloaded taken to start new movement

If restricted livestock being moved from one place to another are unloaded before reaching their destination, the restrictions imposed by this notice apply separately to:

(a) the movement from the starting place to the place of unloading; and

(b) the movement from the place of unloading to the destination.

3 Requirement for inspection, treatment and movement permit

- (1) If restricted livestock in the Infected Zone are to be moved into or through the Free Zone or Control Zone, the owner of the livestock must ensure that the movement does not start unless:
 - (a) the livestock meet the requirements of a clean inspection and Level 1 treatment specified in Table 2; and
 - (b) a declared area movement permit has been granted for the movement.
- (2) Subclause (1) does not apply if the movement is carried out in accordance with an approved program or approved by the Chief Inspector.
- (3) If restricted livestock in the Control Zone are to be moved within the Control Zone or into or through the Free Zone from a property with an approved program, the owner of the livestock must ensure that the movement does not start unless:
 - (a) the movement is carried out in accordance with the approved program; and
 - (b) a declared area movement permit has been granted for the movement.
- (4) If restricted livestock in the Control Zone are to be moved from a property without an approved program as specified in Table 1, the owner of the livestock must ensure that the movement does not start unless:
 - (a) the livestock meet the requirements of a clean inspection and the treatment specified in Table 1 for the property from which the livestock is moved; and
 - (b) a declared area movement permit has been granted for the movement.

4 Clean inspection

- (1) The clean inspection requirement is met if an inspector, after inspecting all of the restricted livestock that are to be moved, declares that all of the livestock are free of live cattle ticks.
- (2) The inspection for cattle ticks is to be carried out on the same day as the required treatment, but before that treatment is carried out.
- (3) If an inspector finds live cattle ticks on any of the livestock to be moved, a further inspection is to be carried out on all of the livestock in accordance with subclause (2).
- (4) A further inspection under subclause (3) must not be carried out within 3 days after the previous inspection without the approval of the Chief Inspector.

5 Treatment

- (1) A Level 1 or Level 2 treatment requirement is met if the livestock are treated in accordance with the requirements specified in Table 2 within 24 hours before movement starts or any longer period not exceeding 48 hours approved by an inspector.
- (2) All Level 1 and Level 2 treatments must be carried out under the supervision of, and in the manner approved by, an inspector.

- (3) A plunge dip treatment requirement is met if the livestock are fully immersed in a certified solution that was certified:
 - (a) for an export yard within the previous 30 days; or
 - (b) for other yards within the previous 60 days.
- (4) A spray dip treatment requirement is met if the livestock are thoroughly sprayed with a solution approved by an inspector.
- (5) A macrocyclic lactone treatment requirement is met if the livestock are treated with a registered macrocyclic lactone in accordance with the instructions of the manufacturer.

About 1 in 100 donors feel faint (dizzy, light-headed, hot, sweaty or unwell) during or straight after donating. Even fewer, about 1 in 1000, faint (lose consciousness).

Some donors may feel faint or faint after leaving the donor centre.

Tips to reduce the risk of fainting

In the 24 hours before you donate, drink plenty of fluids, especially in warm weather.

- In the 3 hours before:
- Drink 750 mL of fluids
- Have something savoury to eat
- Avoid strenuous exercise

Afterwards, spend at least 15 to 20 minutes in the refreshment area.

For 8 hours after:

- Drink plenty of fluids
- Avoid alcoholic and hot drinks
- · Avoid standing for long periods
- Avoid getting overheated.

For at least 12 hours, avoid strenuous or hazardous activities, including jobs where public safety may be affected.

You should check any employment or safety requirements you have. If unsure, please discuss at your interview.

If you feel faint:

- · Lie or sit down with your head between your knees
- · Ask for help
- If you're driving, pull over, park, lay your seat back and call for assistance.
- Do not continue driving.

Bruising

Small bruises are not uncommon and generally resolve in a few days. Larger bruises, which may be uncomfortable, occur once in every 300 donations. To reduce the risk:

- Keep the bandage on for 2 hours
- Minimise lifting or carrying with your donation arm for 24 hours.

If you develop a bruise, an ice pack and/or pain reliever may

help. If you bleed, apply pressure and raise your arm.

Iron levels

Blood donation can cause low iron (iron deficiency), particularly in:

- frequent whole blood donors
- women of child-bearing age.

Low iron may cause tiredness, difficulty concentrating and low haemoglobin (anaemia).

We check haemoglobin before each donation, but not iron. Haemoglobin can be normal in early iron deficiency.

We recommend

- A healthy, iron-rich diet
- Women 18-45 take iron after each whole blood donation
- Women trying to become pregnant build healthy iron levels for the increased requirements of pregnancy.

Speak with your doctor before donating if you're concerned about iron or how often to donate. For more information ask our staff or visit **lifeblood.com.au**

Rare complications may occur in 1 in every 1500 donations and include:

- Nerve irritation
- Local infection or clot
- · Insertion of the needle into an artery.

Testing your donation

To ensure patient safety, we test all successful donations for hepatitis B, hepatitis C and HIV (AIDS virus). We test some donation types for HTLV and syphilis.

If your results are significantly abnormal, we'll notify you using the contact details you provided.

You can change your mind about donating any time. Just tell a staff member.

If you learn of any reason why your blood shouldn't be used, please call us on 13 14 95. In particular, notify us immediately if you:

- Develop a cough, cold, diarrhoea or other infection within a week of donating, or
- Are diagnosed or hospitalised with a serious infection within 2 months of donating

Remember, our staff are trained to deal with any potential problems and are here to help. If you have any questions or concerns, or you feel unwell, please ask a staff member.

- Most of the time, we'll use your donation to help people who are unwell. This may include the supply of plasma from your donation to CSL Behring who is contracted by the Australian government to manufacture plasma-derived medicines for Australians.
- · Your donation may be used by Lifeblood or other approved organisations for the purposes of research, teaching and checking quality.
- We may supply some red cells from your donation for the production of red cell testing kits which are used by hospitals, pathology services and blood banks in Australia to assist in the correct matching of blood for transfusions.
- A part of your donation will also be stored in our Blood Sample Archive for possible future testing and research; samples that are no longer required will be destroyed.

Approval from an appropriate Human Research Ethics Committee is required before any research is undertaken on any part of your donation.

Occasionally we may ask you to undergo follow up tests which you have the option to decline.
