Traffic Act

Approval of Persons to Test Accuracy of Traffic Infringement Detection Devices

I, Reece Philip Kershaw, Commissioner of Police:

(a) under section 44(3) of the *Traffic Act* and with reference to section 43 of the *Interpretation Act*, revoke approvals given under the Act approving a person to be authorised to test the accuracy of traffic infringement detection devices that are in force, notified in:

- i. Government Gazette No. G39, dated 25 September 2013; and
- ii. Government Gazette No G18, dated 6 May 2015.

(b) under section 44(3) of the *Traffic Act*, approve each person specified in the Schedule as qualified to test the accuracy of the following traffic infringement detection devices:

- i. 'BEEIII, Automatic Same Direction Traffic Radar', approved as a traffic infringement detection device by a notice published in Government Gazette No. G37, dated 13 September 2006; and
- ii. 'LTI 20-20 Ultralyte Traffic Laser', approved as a traffic infringement device by a notice published in Government Gazette No. G23, dated 9 June 2010.

Drug Analysis Instrument**
