# **Revocation of Delegation and Delegation**

- I, Natasha Kate Fyles, Minister for Health:
- (a) under section 7(2)(a) of the *Contracts Act 1978*, revoke the delegation of my powers and functions made by instrument entitled "Revocation of Delegation and Delegation" dated 20 September 2017; and
- (b) under section 7(1)(a) of the Act and with reference to section 7(2)(c) of the Act and section 46A of the *Interpretation Act 1978*, delegate my powers and functions under section 5 of the *Contracts Act 1978* to each person from time to time holding, acting in or performing the duties of a position specified in the Schedule, Part A, subject to the conditions and limitations specified in the Schedule, Part B.

#### Part B

- The total value of a contract (including all its constituent parts) entered into by a delegate mentioned in Schedule, Part A, column 1 must not exceed the amount specified opposite in column 2.
- The delegated powers must not be exercised in relation to a contract containing a guarantee or indemnity given by the Territory unless prior approval is obtained under section 34(1) of the *Financial Management Act 1995*.
- 3 The delegated powers and functions may only be exercised:
  - (a) in relation to a contract relevant to the delegate's area of responsibility;and
  - (b) subject to any applicable budget constraints.
- As soon as practicable after entering into a contract, the delegate must give a copy of the contract to the division within the Department of Health responsible for maintaining the Contracts Awareness List.
