# Northern Territory of Australia Bushfires Management Act 2016

#### Revocation of Declaration and Declaration of Fire Protection Zone Tennant Creek

- I, Eva Dina Lawler, Minister for Environment and Natural Resources:
- (a) under section 56 of the Bushfires Management Act 2016 and with reference to section 43 of the Interpretation Act 1978, revoke the declaration made in clause (c)(ii) of the notice entitled "Appointment of Person to be Member of Regional Bushfires Committee in Respect of Northern Fire Control Region – Declaration of Fire Protection Zones – Establishment of Voluntary Bushfire Brigades" dated 24 November 1981 and published in Gazette No. G48 of 4 December 1981; and
- (b) under section 56 of the Bushfires Management Act 2016, declare the land described in Schedule 1 and shown bounded by thick dashed lines on the map in Schedule 2 for information purposes only to be a fire protection zone.



#### Schedule 1

All that area of land in the Barkly Region of the Northern Territory of Australia containing an area of 1,748 square kilometres more or less and bounded by lines described as follows:

Commencing at the north western corner of Northern Territory Portion 4697 then head west to the centreline of the Stuart Highway; then head generally southerly along said centreline to the prolongation of the north eastern corner of Northern Territory Portion 4071; then head westerly along the northern boundary of said portion; then head southerly along the western boundaries of NT Portions 4071 and 4449 to the centreline of Warrego Road; then generally north westerly along said centreline to the prolongation of the south eastern corner of Northern Territory Portion 7025; then westerly along the southern boundary of said portion to the centreline of the Darwin Alice Springs Railway; then head generally south easterly along said centreline to the prolongation of the northern boundary of Northern Territory Portion 4115; then head westerly, then southerly along the northern, western boundaries of the said portion; then head southerly then easterly along the western and southern boundaries of Northern Territory Portion 4236 to the centreline of the Stuart Highway; then head southerly along the said centreline to the prolongation of the Murtulki Track; then head generally north easterly along the centreline of the Murtulki track through Northern Territory Portions 4068 and 1375; then head generally westerly along the centreline of the Gosse River Road through Northern Territory Portions 4068 and 1075; then head north along the eastern boundary of Northern Territory Portion 3735; then head east, then north, then west, then north again, then west again along the eastern boundaries of Northern Territory Portion 494; then head generally north easterly along an unnamed track through Northern Territory Portion 3723 starting at the prolongation of the eastern boundary of Northern Territory Portion 2441 and ending at the centreline of the Barkly Highway; then head westerly along said centreline to a southerly prolongation of the most eastern point of Northern Territory Portion 4697; then head westerly along the northern boundary of said portion to point of commencement. The Tennant Creek Protection Zone excludes the area described as the Tennant Creek Fire District (now known as Tennant Creek Emergency Response Area) dated 25 August 1993 and published in Gazette No. G37 15 September 1993.

#### Bushfires Management Act 2016

#### Revocation of Declaration and Declaration of Fire Protection Zone Alice Springs

- I, Eva Dina Lawler, Minister for Environment and Natural Resources:
- (a) under section 56 of the Bushfires Management Act 2016 and with reference to section 43 of the Interpretation Act 1978, revoke the declaration made by notice entitled "Declaration of Fire Protection Zone" dated 17 April 1979 and published in Gazette No. G17 of 27 April 1979; and
- (b) under section 56 of the Bushfires Management Act 2016, declare the land described in Schedule 1 and shown bounded by thick dashed lines on the map in Schedule 2 for information purposes only to be a fire protection zone.

#### Schedule 1

All that area of land in the Alice Springs Region of the Northern Territory of Australia containing an area of 11,862 square kilometres more or less and bounded by lines described as follows:

Commencing at the north eastern corner of Northern Territory Portion 650; then head west along the northern boundary of the said portion; through Northern Territory Portion 3805; continue west along northern boundary of Northern Territory Portion 650; then across Alice Springs Darwin Railway and Stuart Highway easement; continue west along the northern boundary of Northern Territory Portion 650 and northern boundary of Northern Territory Portion 4423 to its north western corner; then head south westerly along the boundary of the said portion to the centreline of Tanami Road; then head north westerly along centreline of Tanami Road to the prolongation of the boundary of Northern Territory Portion 4423; then head generally southerly, then generally westerly to the western boundary of said portion; then head south along western boundary of said portion and Northern Territory Portion 4156 to the north eastern corner of Northern Territory Portion 3719; then head west on the northern boundary of said portion to the south eastern corner of Northern Territory Portion 4116; then head north westerly, then north easterly, then north westerly, then south following the boundary of the said portion; then head generally south easterly, then south along the western boundaries of Northern Territory Portions 3719 and 951 crossing the Namatjira Drive easement; then head westerly along the western boundary of Northern Territory Portion 3719 crossing the Namatjira Drive easement, then south along the boundary of Northern Territory Portion 3719; then head east along the southern boundary of Northern Territory Portion 3719 across the Namatjira Drive easement; then continue east along the southern boundaries of Northern Territory Portions 831, 4626 and 4627 again crossing the Namatjira Drive easement to the south eastern corner of Northern Territory Portion 3719; then head south along the western boundary of Northern Territory Portion 3290 across Namatjira Drive easement to the south western corner of said portion; then east along the southern boundary of the said portion again across Namatjira Drive easement and continue east along southern boundaries of Northern Territory Portions 779 and 6867 to the north western corner of Northern Territory Portion 6631; the head south, then east, then north following boundary of said portion to its north eastern corner; then head east along the southern boundary of Northern Territory Portion 6867 to its south eastern corner; then head south along the western boundary of Northern Territory Portion 6991 crossing the Namatjira

Drive easement and continue south along western boundary of Northern Territory Portion 1406 to the south western corner of said portion crossing Larapinta Drive easement; then head generally easterly along the southern boundary of Northern Territory Portion 1406 across Stuart Highway easement to south eastern corner of said portion; then head north, then east along boundaries of said portion crossing the Alice Springs Tarcoola Railway easement to the centreline of Old South Road; then head generally northerly along the centreline of Old South Road to the prolongation of the south western corner of Northern Territory Portion 7723; then head generally easterly along the southern boundaries of Northern Territory Portions 7723, 7722 and Ooraminna Station access road easement to the centreline of the Santa Teresa Road; then head generally northerly along the centreline of the Santa Teresa Road to prolongation of southern boundary of Northern Territory Portion 771; then head east, then north, then east again, then north again, then east again, then north again along the boundaries of the said portion crossing Todd River Road and Ringwood Road easements; then head north westerly, then west, then north again, then west again along the boundaries of the said portion crossing the Ross Highway easement to the eastern boundary of Northern Territory Portion 650; head north along the eastern boundary of said portion to point of commencement. The Alice Springs Fire Protection Zone excludes the area described as the Fire District Alice Springs (now known as Alice Springs Emergency Response Area) dated 29 June 1995 and published in Gazette No. G30 of 26 July 1995.
