### Revocation and Establishment, Naming and Declaration of Government School and Revocation and Establishment of School Management Council

## Termination and Appointment of School Management Council Zuccoli Primary School

- I, Selena Jane Malijarri Uibo, Minister for Education:
- (a) under sections 15(5), 73(1) and 118(1) of the Education Act 2015 and with reference to section 43 of the Interpretation Act 1978, revoke the actions effected by the instrument entitled "Establishment, Naming and Declaration of Government School and Establishment of School Management Council Zuccoli Primary School" dated 26 August 2019 and published in Gazette No. G36 on 4 September 2019; and
- (b) under section 118(4) of the *Education Act 2015* and with reference to section 44(1) of the *Interpretation Act 1978*, terminate the appointment of Carolyn Gail Edwards to comprise the school management council established for Zuccoli Primary School; and
- (c) under section 15(5)(a) of the *Education Act 2015*, establish a Government school at Lot 14493, 130 Zuccoli Parade, Zuccoli NT 0832; and
- (d) under section 15(5)(c) of the Act, name the Government school "Zuccoli Primary School"; and
- (e) under section 73(1) of the Act, declare Zuccoli Primary School to be a Government school; and
- (f) under section 118(1)(a) of the Act, establish a school management council for Zuccoli Primary School; and
- (g) under section 118(4) of the Act and with reference to section 118(5) of the Act, appoint Carolyn Gail Edwards to comprise the school management council established for Zuccoli Primary School.

# Northern Territory of Australia Petroleum Act 1984


#### Reservation of Blocks - RB 198
