**Revocation of Code of Practice and**  
**Code of Practice Schedule 8 Substances**

I, Hugh Crosbie Heggie, Chief Health Officer:

- a) under sections 244(1) and 244(4) of the *Medicines, Poisons and Therapeutic Goods Act 2012* and with reference to section 43 of the *Interpretation Act 1978* revoke the instruments entitled:
- i. “Code of Practice Schedule 8 Substances” dated 17 April 2014 and published in Gazette No. G16 of 23 April 2014; and
  - ii. “Code of Practice” dated 26 September 2018 and published in *Gazette* No. S79 of 1 October 2018; and
