Dangerous Goods Regulations 1985

Approval of Periods for Purchasing, Possessing and Throwing, Igniting or Exploding Shopgoods Fireworks

- I, Natasha Kate Fyles, Attorney-General and Minister for Justice:

 - (ii) from 6 11 approve the period of time pm to on pm Wednesday 1 July 2020 as a period during which a person may throw, ignite or explode shopgoods fireworks, subject to the condition that this approval does not apply to the place specified in the Schedule.
