### FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, L. A. Polkinghorne (hereinafter referred to as the 'permit holder'), P.O. Box 467, Port Lincoln, S.A. 5606, is exempt from section 41 of the Fisheries Act 1982, subject to the conditions specified in Schedule 1, in that the permit holder shall not be guilty of an offence when taking southern rock lobster (lasus edwardsii), in the closed season (hereinafter referred to as the 'permitted activity').

#### SCHEDULE 1

- 1. This permit is valid from the date of gazettal of this notice to 30 October 1999.
- 2. All southern rock lobster (*Jasus edwardsii*) are to be taken for Fishery Management Committee promotional purposes and must not be sold.
- 3. No more than a total of 150 kg of southern rock bbster (*Jasus edwardsii*) may be taken pursuant to this notice.
- 4. The permit holder must notify a PIRSA Fisheries and Aquaculture Compliance Officer on 1800 065 522 at least two hours prior to landing southern rock lobster (*Jasus edwardsii*).
- 5. All southern rock lobster (Jasus edwardsii) taken pursuant to this notice are to be delivered to registered fish processors FP0044 Australian Bight Seafoods and/or FP0118 Southern Ocean Rock Lobster Pty Ltd (hereinafter referred to as the 'approved fish processors'). Immediately upon delivery of rock lobster to one of the approved fish processors, the permit holder must record the accurate weight of rock lobster delivered and retain a record showing the date and weight of all southern rock lobster landed pursuant to this notice.
- 6. The permitted activity may only be conducted from the boat  ${\it Untouchable}.$
- 7. A maximum of 60 rock lobster pots may be used to conduct the permitted activity.
- 8. The permitted activity may only be conducted in those waters of the Northern Zone Rock Lobster fishery.

- 9. PIRSA Fisheries and Aquaculture retains the right for a departmental officer to observe the permitted activity at any time
- 10. Whilst engaged in the permitted activity the permit holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries and Aquaculture Compliance Officer.
- 11. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

Spencer (hereinafter referred to as the 'permit holder'), 56 Yardea Street, Port Lincoln, S.A. 5606, is exempt from section 41 of the Fisheries Act 1982, subject to the conditions specified in Schedule 1, in that the permit holder shall not be guilty of an offence when taking southern rock lobster (Jasus edwardsii), in the closed season (hereinafter referred to as the 'permitted activity').

Immediately upon delivery of rock lobster to one of the approved fish processors, the permit holder must record the accurate weight of rock lobster delivered and retain a record showing the date and weight of all southern rock lobster landed pursuant to this notice.

- 6. The permitted activity may only be conducted from the boat  $Jo\text{-}Be\ 2$ .
- 7. A maximum of 60 rock lobster pots may be used to conduct the permitted activity.
- 8. The permitted activity may only be conducted in those waters of the Northern Zone Rock Lobster fishery.
- 9. PIRSA Fisheries and Aquaculture retains the right for a departmental officer to observe the permitted activity at any

TAKE notice that pursuant to section 59 of the Fisheries Act 1982 that Darren Ness or persons acting as his agents for and on behalf of Posaqua Management Services Pty Ltd (hereinafter referred to as the 'fisher'), P.O. Box 17, Kadina, S.A. 5554 is exempt from part 3, section 6(d) of the Fisheries (General) Regulations 1984, subject to the conditions specified in Schedule 1, in that the fisher shall not be guilty of an offence when taking and possessing up to a maximum of 50 female blue swimmer crabs (*Portunus pelagicus*) with eggs attached (hereinafter referred to as the 'permitted activity') from the date of this notice until 30 June 2000.

#### SCHEDULE 1

- 1. All blue swimmer crabs (*Portunus pelagicus*) taken pursuant to this notice (or their progeny) must not be returned to the water.
- 2. All blue swimmer crabs (*Portunus pelagicus*) taken pursuant to this notice must be held at the registered aquaculture site FT00549
- 3. All female blue swimmer crabs *Portunus pelagicus*) with eggs attached shall be for aquaculture broodstock purposes only and shall not be sold.
- 4. Whilst engaged in the permitted activity the fisher must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries and Aquaculture Compliance Officer.
- 5. The fisher must notify the Compliance Unit of PIRSA Fisheries and Aquaculture on 1800 065 522 prior to conducting fishing operations pursuant to this notice and provide the following information:
  - the name of the nominated person conducting the permitted activity;
  - the name and registered number of any boat used whilst conducting the permitted activity; and
  - the intended time and date which the permitted activity is to be conducted; and
  - the intended location in which the permitted activity is to be conducted.

6. The fisher shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.

#### FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, Massena Abalone (hereinafter referred to as the 'permit holder'), 51 London Street, Port Lincoln, S.A. 5606, is exempt from the Fisheries Act 1982, insofar as they may take greenlip abalone (*Haliotis laevigata*) and blacklip abalone (*Haliotis rubra*) for the purpose of aquaculture broodstock in the waters specified in Schedule 1 subject to the conditions in Schedule 2 (hereinafter referred to as the 'permitted activity').

#### SCHEDULE 1

South Australian coastal waters south and east of a line drawn due south through Point Brown (latitude 32°32.6′S, longitude 133°50.8′E) and west of the meridian of longitude 136°30′E.

In the waters between Point Bolingbroke and the Sir Joseph Banks Group.

#### SCHEDULE 2

- 1. The permit holder may take a maximum of 100 greenlip abalone (Haliotis laevigata) and a maximum of 100 blacklip abalone (Haliotis rubra). All abalone taken pursuant to this notice may not be sold or transferred to another party.
- 2. The permit holder may engage in the permitted activity from the date of gazettal of this notice until 30 June 2000.
- 3. The permitted activity may only be conducted by Darren Tressider.
- 4. The permit holder shall notify the PIRSA Fisheries and Aquaculture Compliance Unit on 1800 065 522 at least 24 hours prior to conducting the permitted activity with the following information:
  - (a) details of the boat that will be used to engage in the permitted activity;
  - (b) the name of the person who will be conducting the permitted activity;
  - (c) the intended place and time of launching and retrieval of the nominated boat for that day; and
  - (d) the intended area of conducting the permitted activity.
- 5. The permit holder must, within 50 m of the point of landing of any abalone taken pursuant to this notice, complete the PIRSA Aquaculture Abalone Broodstock Collection Statement. Immediately upon arrival at the permit holders registered aquaculture site, this form must be faxed to PIRSA Fisheries and Aquaculture on (08) 8226 2320. Prior to release into the registered aquaculture site, all abalone taken pursuant to this notice must be tagged so as to be clearly identified as wild broodstock.
- 6. The permit holder shall record the number of wild broodstock held pursuant to this notice in a register to be maintained at the registered aquaculture site, which must be made available for inspection by a Fisheries Compliance Officer upon request.
- 7. PIRSA Fisheries and Aquaculture retains the right for a departmental officer to accompany the fisher at any time during the permitted activity.
- 8. While engaged in the permitted activity the permit holder shall carry or have about or near his person a copy of this notice. Such notice must be produced to a Fisheries Compliance Officer upon request.
- 9. The permit holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

#### FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, I hereby authorise N. D. and W. P. Ramsey (or their agent) (hereinafter referred to as the 'fish farmer'), Box 6, Arno Bay, S.A. 5603, to engage in the activities and to do the acts specified in Schedule 1, subject to the conditions specified in Schedule 2 from the date of this permit until revoked by the Director of Fisheries.

#### SCHEDULE 1

The importation and release of black bream (Acanthopagrus butcheri), blacklip abalone (Haliotis rubra), greenlip abalone (Haliotis laevigata), snapper (Pagrus auratus), yellowtail king fish (Seriola lalandi), mulloway (Argyrosomus hololepidotus), southern calamari (Sepioteuthis australis), trevally (Caranx georgianus), into ponds, tanks and dams, section 10 in the Hundred of Boothby.

#### SCHEDULE 2

- 1. The fish farmer must maintain adequate security arrangements to prevent escapement of fish (ova, fry or adult) into any South Australian waters.
- 2. Fish obtained within South Australia for use on the fish farm must be obtained from registered fish farmers, licensed fishers or other persons approved by the Director of Fisheries.
- 3. Fish must not be collected from rivers, streams, lakes or other inland waters of this State unless prior approval for this collection is granted by the Director of Fisheries.
- 4. The fish farmer must not import any live fish (ova, fry or adult) into South Australia unless the shipment has certification from an appropriate authority in the State from which they are obtained that they are free from all relevant notifiable diseases listed in Schedule 4 of the Fisheries (Exotic Fish, Fish Farming and Fish Diseases) Regulations 1984.
- 5. The fish farmer must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically permitted by this notice.
- 6. The fish farmer must retain the copy of this permit which has been supplied by the Director of Fisheries, and if requested by a PIRSA Fisheries and Aquaculture Compliance Officer, produce that permit for inspection.
