Water Rates in Respect of Non-Commercial Land (except Residential and Vacant Land)

PURSUANT to section 65C (1) (d) of the Waterworks Act 1932, and after consultation with the South Australian Water Corporation, I fix the following water rates in respect of all water supplied to all classes of non-commercial land except residential and vacant land for the financial year commencing on 1 July 2000 and ending on 30 June 2001:

(i) for each kilolitre supplied up to, and including, 125 kilolitres—\$0.36 per kilolitre;

(ii) for each kilolitre supplied over 125 kilolitres—\$0.91 per kilolitre.

Supply Charge in Respect of Non-Commercial Land (except Residential and Vacant Land)

PURSUANT to section 65C (1) (a) of the Waterworks Act 1932, and after consultation with the South Australian Water Corporation, I fix the supply charge in respect of all classes of non-commercial land except residential and vacant land for the financial year commencing on 1 July 2000 and ending on 30 June 2001 at \$134.00 per annum.
