Barossa Valley Region—Industry Plan Amendment Report by the Minister—Draft for Public Consultation

NOTICE is hereby given that the Minister for Transport and Urban Planning has, pursuant to Section 26 of the Development Act 1993, prepared a draft Plan Amendment Report relating to the Barossa Valley Region and an area of land adjacent to She-Oak Log within The Barossa Council and the District Council of Kapunda and Light.

The draft Plan Amendment Report will amend the Development Plans by introducing new Industry and Deferred Industry Zones, and policies in existing Rural Zones to guide future winery development and future expansion of certain industrial and commercial activities. A new Extractive Industry Buffer Zone is proposed adjacent to the Penrice Quarry. The draft Plan Amendment Report also proposes public notification categories within the proposed industry and existing Rural Zones.

The draft Plan Amendment Report will be on display from 23 April 1999 to 23 June 1999.

Written submissions regarding the draft Plan Amendment Report should be submitted no later than 23 June 1999. All submissions should be addressed to the Presiding Member, Development Policy Advisory Committee, GPO Box 1815, Adelaide, South Australia 5001 and should clearly indicate whether you wish to be heard in support of your submission.

Copies of all submissions will be available for inspection by interested persons at the Department for Transport, Urban Planning and the Arts (Planning SA), Level 5, 136 North Terrace, Adelaide from 24 June 1999 to 13 July 1999.

A public hearing will be held on 13 July 1999 at the Angaston Office of The Barossa Council commencing at 7.30 p.m., at which time interested persons may appear to be heard in relation to the draft Plan Amendment Report and the submissions. The public hearing will not be held if no public submissions are received or no submission makes a request to be heard.
