FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, Southern Vales Christian Community School, 140 States Road, Morphett Vale, S.A. 5162 (hereinafter referred to as the 'fish farmer') is exempt from the provisions of section 50 (1) of the Fisheries Act 1982, insofar as the fish farmer shall not be guilty of an offence when conducting operations relating to the importation and fish farming of barramundi (*Lates calcarifer*) for the purpose of trade or business (hereinafter referred to as the 'permitted activity'), subject to the conditions specified in the schedule from the date of gazettal of this notice.

SCHEDULE 1

1. The fish farmer may only engage in the permitted activity on the premises situated at Part Section 512 in the Hundred of Noarlunga, as detailed in registered aquaculture site FT00631 (hereinafter referred to as the 'premises').

2. The fish farmer shall not import barramundi (*Lates calcarifer*) into South Australia unless the shipment has been certified disease free by an approved veterinary agency to a protocol approved by PIRSA Fisheries and Aquaculture.

3. The fish farmer must maintain adequate security arrangements to prevent escapement of the barramundi (*Lates calcarifer*) from the premises.

4. The fish farmer must ensure that no waste water enters South Australian waters without the prior permission of the Director of Fisheries.

5. The fish farmer must ensure that no live fish leave the premises without the prior written approval of the Director of Fisheries.

6. The fish farmer shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice. 7. The fish farmer must retain a copy of this notice and produce that notice for inspection if requested by a PIRSA Fisheries and Aquaculture Compliance Officer.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Dr Mike Geddes or persons acting as his agents (hereinafter referred to as the 'permit holder') from the Department of Zoology, University of Adelaide, North Terrace, Adelaide, S.A. 5000 is exempt from the provisions of section 41 of the Fisheries Act 1982 to engage in the activities specified in Schedule 1 (hereinafter referred to as the 'permitted activity'), using the gear specified in Schedule 2, subject to the conditions set out in Schedule 3 for 29 February 2000 and 1 March 2000 inclusive.

SCHEDULE 1

The collection of marine organisms from all waters of South Australia, including intertidal 'rocky' reefs (not including aquatic reserves).

SCHEDULE 2

1. The specimens collected by the permit holders are for scientific purposes only and may not be sold.

2. Collections undertaken from intertidal 'rocky' reef areas must be undertaken with due consideration of other members of the public already in the area.

3. The fisher shall not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.

4. While engaging in the permitted activity, the permit holders must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries and Aquaculture Compliance Officer if such an officer requests that it be produced.

5. Before collecting any specimens pursuant to this notice, the permit holders must advise a Fisheries Compliance Officer of PIRSA Fisheries on 1800 065 522 with details of the proposed locations and the dates on which the collections are to be made.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the class of persons specified in Schedule 1 and Kingston Dive & Charter, RMB 510 Nhill, Vic. 3418 (hereinafter referred to as the 'charter boat operator') is exempt from the provisions of clause 71AA and clause 70 (*b*) of Schedule 1 of the Fisheries (General) Regulations 1984, and section 41 of the Fisheries Act 1982, insofar as the charter boat operator may exceed the boat limits as specified in Schedule 2, subject to the conditions specified in Schedule 3.

SCHEDULE 1

Any person or persons who charter the boat *Pepper* (hereinafter referred to as the 'permitted boat') from the charter boat operator in South Australia, for the purpose of recreational fishing for scalefish, abalone and rock lobster.

SCHEDULE 2

1. The charter boat operator may engage in the taking of no more than one rock lobster (*Jasus edwardsii*) per paying passenger in any one day where the number of paying passengers exceeds eight.

2. The charter boat operator may engage in the taking of no more than one abalone (*Haliotis* spp.) per paying passenger in any one day where the number of paying passengers exceeds 10.

3. The charter boat operator may engage in the taking of no more than one half of the daily bag limit for those species of scalefish subject to such a limit as specified in the Fisheries (General) Regulations 1984, per paying passenger in any one day where the number of paying passengers exceeds five.

SCHEDULE 3

1. This exemption is valid from the date of gazettal of this notice until 30 June 2001.

2. The charter boat operator shall not use any other boats for the purpose of engaging in the permitted activity except the *Pepper*.

3. The charter boat operator shall not sell any fish taken pursuant to this notice.

4. The charter boat operator shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.

5. While engaged in the permitted activity the charter boat operator shall have in their possession a copy of this notice. Such notice must be produced to a PIRSA Fisheries and Aquaculture Compliance Officer if such an officer requests that it be so produced.
