FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Matthew R. Williams (hereinafter referred to as the 'exemption holder'), 8 Elizabeth Street, Port MacDonnell, S.A. 5291 is exempt from section 41 of the Fisheries Act 1982 only insofar as that the exemption holder shall not be guilty of an offence when taking southern rock lobster (Jasus edwardsii), in the closed season (hereinafter referred to as the 'permitted activity') subject to the conditions specified in Schedule 1.

SCHEDULE 1

- 1. This permit is valid from the date of gazettal of this notice to 9 July 2000.
- 2. All southern rock lobster (*Jasus edwardsii*) are to be taken for promotional purposes and must not be sold.
- 3. No more than a total of 40 southern rock lobster (lasus edwardsii) may be taken pursuant to this notice.
- 4. The exemption holder must notify a PIRSA Fisheries Compliance Officer on 1800 065 522 at least two hours prior to landing southern rock lobster (*Jasus edwardsii*).
- 5. All southern rock lobster (Jasus edwardsii) taken pursuant to this notice are to be delivered to registered fish processors FP0447 Willsea Pty Ltd (hereinafter referred to as the 'approved fish processor'). Immediately upon delivery of rock lobster to the

approved fish processor, the exemption holder must record the accurate weight of rock lobster delivered and retain a record showing the date and weight of all southern rock lobster landed pursuant to this notice.

- 6. The permitted activity may only be conducted from the boat *Andree Dean*.
- 7. A maximum of 5 rock lobster pots may be used to conduct the permitted activity.
- 8. The permitted activity may only be conducted in those waters of the Southern Zone Rock Lobster fishery.
- 9. PIRSA Fisheries retains the right for a PIRSA Fisheries Compliance Officer to observe the permitted activity at any time
- 10. Whilst engaged in the permitted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.
- 11. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice. Dated 3 July 2000.
