FISHERIES ACT 1982: SECTION 59

TAKE note that the notice made under section 59 of the Fisheries Act 1982, and published in the *South Australian Government Gazette* on page number 1520, dated 1 September 2000, being the second notice on that page, referring to the collection of aquatic organisms, is hereby revoked.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Teresa ter Bogt or persons acting as her agents (hereinafter referred to as the 'exemption holder') of Renmark to the Border Local Action Planning Association Inc., 117 Ral Ral Avenue, Renmark, S.A. 5341 is exempt from the provisions of the Fisheries Act 1982, but only insofar as the exemption holder may engage in the collection of aquatic organisms from the waters of Ral Ral Creek located within 100 m of the Calperum Causeway using a maximum of four drum nets and one gill net (hereinafter referred to as the 'exempted activity'), subject to the conditions set out in Schedule 1 from the date of gazettal of this notice until 30 September 2001.

Schedule 1

1. The specimens collected by the exemption holder are for research purposes only and must not be sold.

2. On completion of research assessment, all native fish captured must be released into the area of capture.

3. Before collecting any specimens pursuant to this notice, the exemption holder must advise the PIRSA Fisheries Compliance Unit on 1800 065 522 with details of the proposed locations and the dates on which the collections are to be made.

4. The exemption holder must provide a report in writing detailing the outcomes of the research and the collection of organisms pursuant to this notice to the Director of Fisheries, (Attention: Roger Hill, G.P.O. Box 1625, Adelaide, S.A. 5001) every 6 months from the date of this notice, giving the following details:

- the date and time of collection;
- · the description of all species collected;
- · the number of each species collected; and
- · progress of the research project.

5. While engaging in the exempted activity, the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.

6. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Scott Nichols or persons acting as his agents (hereinafter referred to as the 'exemption holder'), P.O. 2. On completion of scientific assessment, all fish captured must be released into the area of capture, including non-native and exotic fish.

3. Before collecting any specimens pursuant to this notice, the exemption holder must advise the PIRSA Fisheries Compliance Unit on 1800 065 522 with details of the proposed locations and the dates on which the collections are to be made.

4. The exemption holder must provide a report in writing detailing the outcomes of the research and the collection of organisms pursuant to this notice to the Director of Fisheries, (Attention: Roger Hill, G.P.O. Box 1625, Adelaide, S.A. 5001) every 6 months from the date of this notice, giving the following details:

- the date and time of collection;
- the description of all species collected;
- the number of each species collected; and
- progress of the research project.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the class of persons specified in Schedule 1 and Double Header Fishing Charter, 6 St Margarets Drive, Stirling, S.A. 5152 (hereinafter referred to as the 'exemption holder') are exempt from the provisions of Schedule 1 of the Fisheries (General) Regulations 1984, and section 41 of the Fisheries Act 1982, but only insofar as the exemption holder may exceed the boat limits as specified in Schedule 2 (hereinafter referred to as the 'exempted activity'), subject to the conditions specified in Schedule 3.

SCHEDULE 1

Any person or persons who charter the boat *Sea Eagle* (hereinafter referred to as the 'permitted boat') from the exemption holder in South Australia, for the purpose of recreational fishing for scalefish, abalone, blue swimmer crab and rock lobster.

SCHEDULE 2

1. The exemption holder may engage in the taking of no more than one rock lobster (*Jasus edwardsii*) per paying passenger in any one day where the number of paying passengers exceeds eight.

2. The exemption holder may engage in the taking of no more than one abalone (*Haliotis* spp.) per paying passenger in any one day where the number of paying passengers exceeds ten.

3. The exemption holder may engage in the taking of no more than twenty blue swimmer crab (*Portunus pelagicus*) per paying passenger in any one day where the number of paying passengers exceeds six.

4. The exemption holder may engage in the taking of no more than one half of the daily bag limit for those species of scalefish subject to such a limit as specified in the Fisheries (General) Regulations 1984, per paying passenger in any one day where the number of paying passengers exceeds five.

SCHEDULE 3

1. This exemption is valid from the date of gazettal of this notice until 30 September 2001.

2. The exemption holder shall not use any other boats for the purpose of engaging in the exempted activity except the permitted boat.

3. The exemption holder shall not sell any fish taken pursuant to this notice.

4. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.
