RACING ACT 1976

BOOKMAKERS LICENSING (AMENDMENT) RULES 2001

[18 April 2001]

THE Gaming Supervisory Authority makes the following rules:

1. Citation, commencement

- (1) These rules may be cited as the Bookmakers Licensing (Amendment) Rules 2001
- (2) In these rules the Bookmakers Licensing Rules 2000 are called the Principal Rules.
- (3) These rules come into operation on 2 May 2001.
- (4) These rules are made under paragraphs (a) and (b) of section 124 (1) of the *Racing Act 1976*.

2. Miscellaneous amendments

- (1) In Rule 1 (3) of the Principal Rules—
 - (a) strike out the definition of 'Act' and substitute—

"'Act' means-

- (a) prior to the commencement of clause 3 (6) of Schedule 1 to the Authorised Betting Operations Act 2000, the Racing Act 1976;
- (b) on and from the commencement of clause 3 (6) of Schedule 1 to the *Authorised Betting Operations Act 2000*, that Act; "; and

- (b) strike out the definition of 'Authority' and substitute—
 - " 'Authority' has the same meaning as in the Act; "; and
- (c) strike out the definition of 'betting auditorium' and substitute—
 - "'betting auditorium' means a location within a racecourse for which a permit has been issued to allow a bookmaker to make bets;"; and
- (d) in the definition of 'bookmaker' strike out "Part IV of"; and
- (e) strike out the definition of 'controlling authority' and substitute—
 - "'controlling authority' means a controlling authority or a racing controlling authority under the Act;"; and
- (f) strike out the definition of 'registered premises' and substitute—
 - "'registered premises' means premises registered as a betting shop by the Authority;" and
- (2) Rules 2 and 3 of the Principal Rules are revoked.

3. Licensing amendments

- (1) In Rule 1 (3) of the Principal Rules, insert in the appropriate alphabetic sequence—
 - "'Agent's licence' means a bookmaker's licence applied for and granted to a person for the specific purpose of the person making bets as agent on behalf of a principal who is the holder of bookmaker's licence;".
- (2) In Rule 11 (1) of the Principal Rules—
 - (a) strike out "in accordance with the Act and these rules"; and
 - (b) strike out "no other" and substitute "any other"; and
 - (c) immediately before paragraph (a), insert "at any place where the principal could make bets."
 - (d) strike out paragraphs (a) and (b).
- (3) In Rule 14 (1) of the Principal Rules—
 - (a) strike out "(1)"; and
 - (b) strike out "agent's or clerk's licence" and substitute "agent's licence or clerk's licence".
- (4) Rule 14 (2) of the Principal Rules is revoked.
- (5) In Rule 38 of the Principal Rules, strike out "under subsection (1) of section 112a of the Act," and substitute "in respect of a betting auditorium".
- (6) In Rule 123 (4) (f) of the Principal Rules, strike out "in accordance with section 120 of the Act" and substitute "by or with the approval of the Commissioner".
- (7) In Rule 130A (1) (i) of the Principal Rules, strike out "pursuant to section 116 (2) of the Act" and substitute "required to be forwarded to the Commissioner under the Act".
- (8) In Rule 130B(d) of the Principal Rules, strike out "under section 112 of the Act".
