These standard terms and conditions are published in accordance with section 36 (2) of the South Australian Electricity Act 1996 with the approval of the South Australian Independent Industry Regulator and will come into force on 26 May 2001 and when in force will be binding on AGL and each customer to whom these standard terms and conditions are expressed to apply without the need for AGL or those customers to sign any written document containing these terms and conditions in order for them to be binding.

The standard terms and conditions published by AGL in accordance with section 36 (2) of the South Australian Electricity Act 1996 under this notice are the same as the standard terms and conditions published by ETSA Power Pty Ltd on 11 October 1999 (as amended by a subsequent notice published by AGL on 17 February 2000) except that the following clause will be added as clause A.4 of the Special Conditions to those terms and conditions:

'A.4 Notwithstanding clause 4.2 (c), this **contract** will end at the expiry of the **grace period** in relation to all **grace period customers**.'
