DEVELOPMENT ACT 1993: SECTION 46 (4)

Preamble

- 1. The Governor, by notice in the *Gazette* on 23 December 1987 (see p. 1916), declared that Division III of Part V of the Planning Act 1982, applied to development that consisted of or included the form of development specified in Schedule 1, on land in that part of the State specified in Schedule 2, of that notice.
- 2. The declaration was then varied by notice in the *Gazette* on 24 November 1988 (see p. 1839).
- 3. The declaration continues to have force and effect as if it were a declaration of the Minister under section 46 of the Development Act 1993.
- 4. It has been decided that it is appropriate to revoke the declaration.

DEVELOPMENT ACT 1993, SECTION 48: DECISION BY THE DEVELOPMENT ASSESSMENT COMMISSION AS DELEGATE OF THE GOVERNOR

Preamble

- 1. The decision of the Governor under section 48 of the Development Act 1993, to approve the development of the Mildara Blass Winery located on the Sturt Highway, 2 km northeast of Nuriootpa in 10 stages published in the *Gazette* on 7 October 1999.
- 2. An amended proposal to the development of the Mildara Blass Winery was approved by the Development Assessment Commission and the decision was published in the *Gazette* on 8 Lune 2000
- 3. A further amendment was approved by the Development Assessment Commission and the decision was published in the *Gazette* on 31 August 2000.
- 4. Application has now been made to the Development Assessment Commission as delegate of the Governor under section 48 of the Development Act 1993, for the approval of an advertising sign.
- 5. The application is for the erection of a sign constructed of steel frame and clad in powder coated dark grey galvanised steel. The dimensions of the sign are 6 500 mm long and 2 500 mm wide at one end and 2 000 mm wide at the opposite end. The sign will contain the Wolf Blass logo cut out of the stainless steel.

The sign is to be located approximately 1 m behind an existing stone wall and is within the area and ancillary to the development within the ambit of the relevant Ministerial declaration published in the *Gazette* on 26 November 1998 (see *Gazette* 28 November 1998 pp 1605-1607).

- 6. The Development Assessment Commission has, in considering the application, had regard to all relevant matters under section 48(5) of the Development Act 1993.
- 7. The Development Assessment Commission is satisfied that the proposal does not require the preparation of a further or amended Development Report.

Decision

PURSUANT to section 48 of the Development Act 1993, the Development Assessment Commission, as delegate of the Governor, grants development approval of the erection of advertising signage for the Mildara Blass Winery located on the Sturt Highway, 2 km north-east of Nuriootpa, as described in application dated 15 February 2001, subject to the following condition:

CONDITION OF APPROVAL

The development must be carried out in accordance with plans and drawings submitted as part of the application (titled Mildara Blass Main Site Signage and Drawing numbered 00.112.03/01), subject to the qualification that the planting of any eucalypts along the road reserve, as contemplated by those plans and drawings, must not restrict sight distances of vehicles entering Sturt Highway from Pipe Line Road.
