FISHERIES ACT 1982: SECTION 59

TAKE notice that, pursuant to section 59 of the Fisheries Act 1982, Tracy Warland (hereinafter referred to as the 'exemption holder'), P.O. Box 2236, Port Lincoln, S.A. 5606, is exemption from the Fisheries Act 1982, in that she shall not be guilty of an offence when engaging in the collection of marine plankton using one plankton net (hereinafter referred to as the 'exempted activity') subject to the conditions specified in Schedule 1 from the date of gazettal of this notice until 30 April 2002.

SCHEDULE 1

1. The exempted activity may be conducted using one hand held plankton net with a maximum hoop diameter of 30 cm, a maximum depth of net of 1 m and a collection bucket with a maximum capacity of 600 mL.

2. All specimens taken shall be for the supplementing of diet for a seahorse captive breeding program, for the culturing of the specimens collected and may not be sold.

3. All specimens taken pursuant to this notice must be retained at the site endorsed on land based Aquaculture Licence No. FT00550.

4. The exempted activity may only be conducted by Tracy Warland and/or David Warland.

5. The exempted activity may only be conducted in South Australian coastal waters adjacent to Port Lincoln and Coffin Bay.

6. The exempted activity may only be conducted once per week until 31 October 2001 and once per month thereafter until the expiration of this notice.

7. Before collecting any specimens pursuant to this notice, the exemption holder must notify PIRSA Fisheries on 1800 065 522 with details of the proposed location and dates on which collections are to be made.

8. The exemption holder must provide a report to the Director of Fisheries, (Attention Roger Hill, G.P.O. Box 1625, Adelaide, S.A. 5001) within 3 months of the expiry of this notice, giving the following details:

- the date and location of the collections;
- · the description of all species collected;
- the number of each species collected; and
- the success of culturing operations.

9. Whilst engaged in the exempted activity the exemption holder must be in possession of a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.

10. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically permitted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Pang Quong or his agents (hereinafter referred to as the 'exemption holder'), PQ Aquatics, 4 Burrawong Avenue, Seaford, Victoria, is exempt from the Fisheries Act 1982, but only insofar as the exemption holder shall not be guilty of an offence when taking and possessing one egg-bearing male leafy seadragon (*Phycodorus eques*) (hereinafter referred to as the 'exempted activity') subject to the conditions specified in Schedule 1, from South Australian coastal marine waters from the date of this notice until 31 March 2002.

SCHEDULE 1

1. The egg-bearing male leafy seadragon (*Phycodorus eques*) taken pursuant to this notice must be returned to the water as near as practicable to the area of collection once the eggs have been released.

2. The exemption holder shall provide a written report with details of each collection trip, and also the details of the return of the leafy seadragon to the area of collection, to the Director of Fisheries at the completion of the exempted activity.

3. At least 24 hours prior to engaging in the exempted activity, the exemption holder must contact the PIRSA Fisheries Compliance Unit on 1800 065 522 with the following information:

 the name of the person who will be conducting the exempted activity;

• the intended location for conducting the exempted activity;

- · the method of conducting the exempted activity; and
- if using a boat to conduct the exempted activity, the description of the boat and the intended area of launching and retrieval.

4. Whilst engaged in the exempted activity the exemption holder must be in possession of a copy of this notice and must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be produced.

5. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act, except where specifically exempted by this notice.
