#### **ESSENTIAL SERVICES COMMISSION ACT 2002**

Pricing Determination: Inquiry into Electricity Standing Contract Prices

THE letter of referral of the Inquiry from the Minister for Energy to the Commission dated 30 September 2002, and the directions from the Minister pursuant to section 35 of the *Essential Services Commission Act 2002*, required the Commission to consider whether a price determination should be made under Part 3 of the Act, and if satisfied that it should, make such a determination as part of its final report.

Part 3 of the Act allows the Commission to make determinations regulating prices in any manner the Commission considers appropriate, including the fixing of prices.

In making this price determination, the Commission has had regard to the factors specified in sections 6 (1) and 25 (4) of the *Essential Services Commission Act 2002*, and section 35A of the *Electricity Act 1996*.

The Commission is making this determination to substitute amended prices for those published by AGL SA on 30 September 2002 in accordance with its obligations under section 36AA of the *Electricity Act 1996*.

In making this Determination, the Commission is ensuring that AGL SA does not recover more revenue from small customers than is justified by comparison with prudent costs identified by the Commission and a justifiable retail margin. The information used as a basis for this Determination includes the following:

- customer numbers for each tariff identified by AGL SA;
- network charges for ETSA approved by the Commission;
- wholesale electricity costs averaging \$71/MWh over 2003;
- retail operating costs of \$80 per customer for 2003;
- retail margin of 5%;
- GST of 10%.

In undertaking the inquiry, the Commission has modified some of the prudent input costs from those used by AGL SA in preparing its published prices. This has resulted in the Commission making this Determination of new prices for standing contract supply, to apply from 1 January 2003.

In accordance with its powers under section 35A of the *Electricity Act 1996* and section 25 of the *Essential Services Commission Act 2002*, the Commission determines that the following prices will apply for supply under standing contract conditions by AGL SA commencing on 1 January 2003:

#### AGL SA Revised Standing Prices (GST Inclusive)—Effective 1 January 2003

#### Notes:

- 1. AGL SA's standing contract prices and default contract prices are inclusive of the GST.
- 2. Standing contract and default contract price categories will only apply to small customers, that is, those customers who consume less than 160 MWh of electricity per annum in accordance with the following principles:
  - (a) Domestic Light/Power 110 is applicable to all residential consumption (excluding Off-Peak Controlled Load Tariff 116) in premises used wholly or principally as private residences.
  - (b) Charitable Institutions 112 is available to charitable institutions that have been endorsed by the Australian Taxation Office as an income tax exempt Charitable Entity under Subdivision 50-B of the Income Tax Assessment Act 1997.

- (c) Off Peak Controlled Load 116 is for electricity used in permanently installed storage water heaters with a rated delivery of not less than 125 litres, storage space heaters and other approved thermal storage applications. The hours of application are fixed from time to time by AGL SA with control by time switch or other means. This price is only available in conjunction with Tariff 110, 112, 126, 128, or 140.
- (d) General Supply 126 is available only to non-residential customers.
- (e) General Supply Time of Use 128 is available only to non-residential customers and includes customers previously on tariffs 120 + 121 and 130 + 131.
- (f) Obsolete Tariff 140 (formerly Farm Tariff 140) only applies to small customers that were taking supply under this tariff, or who had applied to do so, as at 30 June 1997. Conditions applicable at that date apply.
- 3. Peak period is 0700 hours to 2100 hours from Monday to Friday (Central Standard Time).
- 4. Off peak period is all times other than peak period.
- 5. Where prices change during a billing cycle the bill for that billing cycle will be calculated on the pro-rata basis using:
  - (a) the old price up to and including the date of change, and
  - (b) the new price from the date of change to the end of the billing cycle.

These standing contract prices will apply until this Determination is revoked or replaced by the Commission.
