FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Trevor Bell (hereinafter referred to as the 'exemption holder'), 8 Pennington Avenue, Kingscote, S.A. 5223, holder of Marine Scalefish Fishery Licence No. M041, is exempt from the provisions of section 41 of the Fisheries Act 1982, only insofar as the exemption holder shall not be guilty of an offence when taking undersized fish of the species cockles (*Katelysia spp.*) (hereinafter referred to as the 'exempted activity'), within those waters specified in Schedule 1, subject to the conditions specified in Schedule 2, from the date of gazettal of this notice until 30 June 2003, unless varied or revoked earlier.

SCHEDULE 1

The waters in the vicinity of Kingscote bounded as follows: Commencing at a point at high water mark at Cape Rouge, latitude 35°35'52"S, and longitude 137°37'32"E, then along the geodesic (190°T), to a point at high water mark on the south coast on the Bay of Shoals, latitude 35°38'18"S, and longitude 137°37'05"E, then following the line of high water mark in a generally easterly and southerly direction to a point at high water mark at the landward end of the Kingscote Jetty, latitude 35°39'15"S and longitude 137°38'32"E, then along the geodesic (133°T) for a distance of 2.3 nautical miles to position latitude 35°40'32"S longitude 137°41'00"E, then along the geodesic (033°T) for a distance of 2.1 nautical miles to a position latitude 35°38'50"S longitude 137°42'15"E, then along the geodesic (325°T) to a point at high water mark on Marsden Point, latitude 35°33'55"S and longitude 137°38'07"E, then following the line of high water mark in a generally southerly direction back to the point of commencement.

SCHEDULE 2

1. Any fish taken by the exemption holder pursuant to this notice must be not less than 27 mm in length measured at the greatest dimension.
2. Any fish taken by the exemption holder pursuant to this notice must be used for bait only and must not be sold.

3. While engaged in the exempted activity, the exemption holder shall carry or have about or near his person, a copy of this notice and must be produced to a PIRSA Fisheries Compliance Officer upon request.

4. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulation made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, the class of persons specified in Schedule 1 and Falie Project Ltd, P.O. Box 470, Port Adelaide, S.A. 5015 (hereinafter referred to as the 'exemption holder') are exempt from the provisions of Regulation 18 and Clauses 66, 70, 73, 77A and 77C of Schedule 1 of the Fisheries (General) Regulations 2000 and section 41 of the Fisheries Act 1982, but only insofar as the exemption holder may exceed the boat limits as specified in Schedule 2 and may fillet fish on board the permitted boat (hereinafter referred to as the 'exempted activity'), subject to the conditions specified in Schedule 3.

SCHEDULE 1

Any person or persons who charter the boat *Falie* (hereinafter referred to as the 'permitted boat') from Falie Project Ltd in South Australian waters for the purpose of recreational fishing.

SCHEDULE 2

1. The exemption holders may engage in the taking of no more than one half of the daily bag limit (rounded up to nearest whole number if necessary) (for those species of scalefish subject to such a limit as specified in the Fisheries (General) Regulations 2000) per other exemption holder in any one day, where the number of other exemption holders exceeds six, excluding the principal exemption holder and assistants.

2. The exemption holders may engage in the taking of no more than one rock lobster (*Jasus edwardsii*) per other exemption holder in any one day where the number of other exemption holders exceeds eight, excluding the principal exemption holder and assistants.

3. The exemption holders may engage in the taking of no more than one abalone (*Haliotis spp.*) per other exemption holder in any one day where the number of other exemption holders exceeds ten, excluding the principal exemption holder and assistants.

4. The exemption holder may fillet and store fish caught from the permitted boat during the period of a fishing trip exceeding 24 hours.

SCHEDULE 3

1. This exemption is valid from the date of gazettal of this notice until 30 June 2003, unless varied or revoked earlier.

2. The exemption holder shall not use any boat other than the permitted boat for the purpose of engaging in the exempted activity.

3. The exemption holder shall not sell any fish taken pursuant to this notice.

4. The exemption holder must contact PIRSA Fisheries Compliance on 1800 065 522 at least 24 hours prior to commencing the exempted activity and advise the time and date of departure of the permitted boat and the estimated time of return to port.

5. All employees of the exemption holder on board the permitted boat must have completed an instruction session with the PIRSA Fisheries Compliance Unit prior to undertaking the exempted activity.

6. All fish filleted during trip must be left with the skin intact and stored with not more than 2 fillets per bag. Each bag must be marked with date of capture.

7. The exemption holder shall not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under that Act except where specifically exempted by this notice.

8. While engaged in the exempted activity the exemption holder shall have in their possession a copy of this notice. Such notice must be produced to a PIRSA Fisheries Compliance Officer if such an officer requests that it be so produced.

FISHERIES ACT 1982: SECTION 59

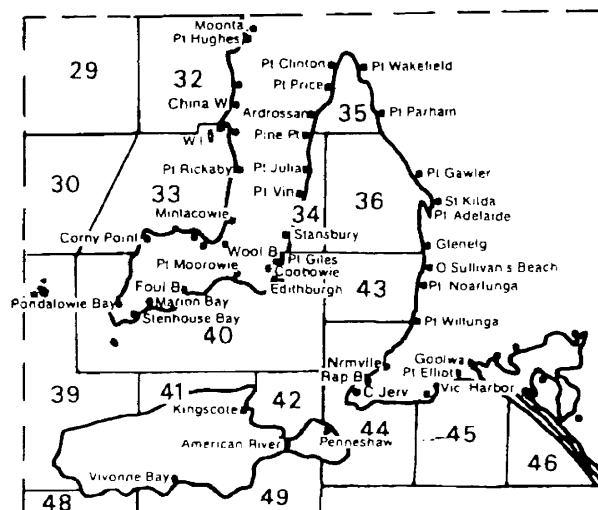

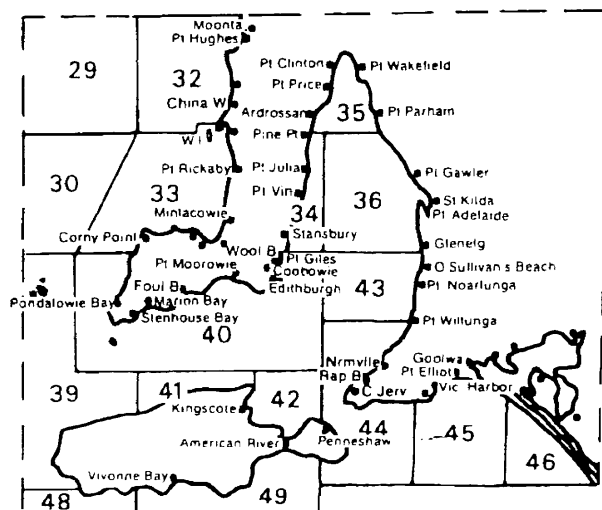

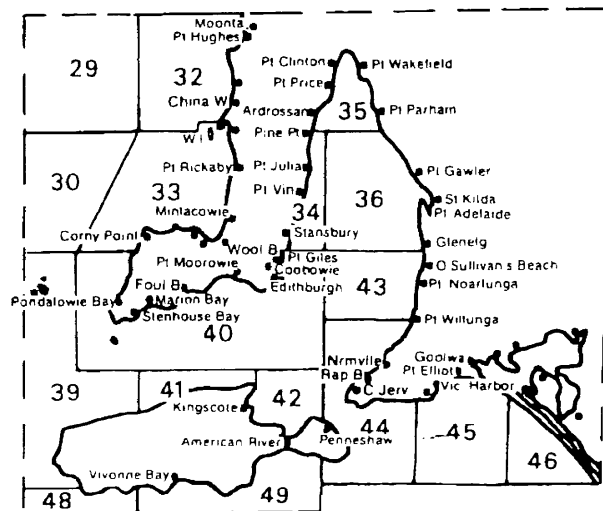
