



- 1. Portion of the unnamed public road adjoining sections 186 and 187 in the Hundred of Alexandrina and portion of D'Aranda Terrace adjoining allotment 1 in Filed Plan 40909, more particularly lettered 'A' and 'B' (respectively) on Preliminary Plan No. 32/0592 be closed.
 - 2. Vest the whole of the land subject to closure in the Crown.

Exemption for Left Hand Drive Agricultural Machines

1. Exemption


- 1.1 Pursuant to section 163AA of the Road Traffic Act 1961, I hereby exempt Left Hand Drive Agricultural Machines from the following provisions of the:
 - 1.1.1 Road Traffic (Vehicle Standards) Rules 1999:
 - Rule 27 (1)—Steering: A motor vehicle must have a right-hand drive.

subject to the conditions specified in this Notice.

2. Definition


- · 'Agricultural machine' means a machine with its own motive power, built to perform agricultural tasks.
- 'Left hand drive vehicle' means a motor vehicle that has its steering wheel on the left of the longitudinal axis of the vehicle.
- 3. Conditions Applying to this Exemption
 - 3.1 The driver's view, from the seating position of the vehicle, of the road and traffic to the front and sides of the vehicle must cover at least 80 degrees to the left and 80 degrees to the right with no more than one 10 degree blind spot in the forward vision area and, no blind spot is permitted within 10 degrees of the longitudinal centre line that intersects the driver's seating position, nor between 60 and 80 degrees of the longitudinal centre line that intersects the driver's seating position. Reference Fig 1 below.

FIG 1, DRIVER VISION - MINIMUM REQUIREMENTS



- 3.2 The agricultural machine shall not travel within the Adelaide Area (Metropolitan).
- 3.3 For the purposes of this notice, the 'Adelaide Area (Metropolitan)' is defined as the area described in 'Map 1, Adelaide Area (Metropolitan)' of this notice.

- 3.4 If the agricultural machine has a retractable boom, the boom must be retracted and stored below the operator's cabin level while travelling on the road or road related area.
- 3.5 Left hand and right hand exterior mirrors must be fitted which, by themselves or in conjunction with an interior mirror, provide the driver with a clear unobstructed view to the rear.
- 3.6 The agricultural machine shall display a warning light or lights (revolving yellow flashing light/s) so that the light emanating from at least one of them is clearly visible at a distance of 500 metres in any direction and which meets the following specification:
 - 3.6.1 Emit a rotating, flashing, yellow coloured light; and
 - 3.6.2 Flash at a rate between 120 and 200 times per minute; and
 - 3.6.3 Have a power of at least 55 watts; and
 - 3.6.4 Not be a strobe light.
- 3.7 The headlights must be fitted with a dipping device to deflect the light projected from the headlight downwards, or downwards and to the left.
- 3.8 This notice or a legible copy of this notice shall be carried by the driver of the vehicle at all times when operating under this exemption and be produced when requested by an inspector appointed under the Road Traffic Act 1961 and/or the Motor Vehicles Act 1959, or a Police Officer.
- 3.9 Oversize or Overmass agricultural machine must also operate in accordance with the 'Code of Practice for Oversize or Overmass Agricultural Vehicles' dated May 2002, issued by Transport SA.
- 3.10 The agricultural machine must meet all other requirements set out in the Road Traffic Act 1961 and Regulations.
- 3.11 The agricultural machine is conditionally registered pursuant to the requirements of Section 25 of the Motor Vehicles Act 1959.





The inclusion of the Kangaroo Flat Restricted Area within the Northern Adelaide Plains Prescribed Wells Area will ensure that all irrigators extracting from the aquifer system are subject to the same conditions of use as will be set out in a water allocation plan and enable the underground water resources of the region to be managed and used in accordance with the Object of the Water Resources
