FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Barry D. Jennings, Lot 100, Main Road, Nildottie, S.A. 5238, holder of River Fishery Licence No. R24 pursuant to the Scheme of Management (River Fishery) Regulations 1991, (the 'exemption holder') is exempt from section 41 of the Fisheries Act 1982, but only insofar as the exemption holder may take fish for trade or business using a haul net of a maximum length of 240 m with a minimum mesh size of 100 mm and a maximum drop of 2.7 m (the 'exempted activity'), subject to the conditions outlined in Schedule 1, from the date of gazettal of this notice until 30 June 2003, unless varied or revoked earlier.

SCHEDULE 1

- 1. The exempted activity cannot be undertaken in the mainstream of the River Murray.
- 2. While undertaking the exempted activity, the exemption holder shall only fish for European carp (*Cyprinus carpio*), bony bream (*Nematalosa eribi*) and non-native species from permitted backwaters.
- 3. Fish, other than carp, bony bream and non-natives that are taken in the course of the exempted activity, must be immediately returned to the water unencumbered in any way and with as little injury as possible.
- 4. While undertaking the exempted activity, the exemption holder may use a gaff or dab net to remove fish from the netting operation.
 - 5. The hauling net must not be used as a set net in backwaters.
- 6. The exemption holder must notify the PIRSA Fisheries compliance unit on 1800 065 522 at least 24 hours prior to conducting the exempted activity and provide the following information:

- the name and licence number of the exemption holder;
- · the intended fishing area;
- the intended fishing period.
- 7. Whilst engaged in the exempted activity, the exemption holder must be in possession of a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries compliance officer.
- 8. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982 or any regulations made under that Act, except where specifically exempted by this notice.

FISHERIES ACT 1982: SECTION 59

TAKE notice that pursuant to section 59 of the Fisheries Act 1982, Stephen Morris (the 'exemption holder'), c/o Clearwater Koi, P.O. Box 68, Woodcroft S.A. 5162 is exempt from Schedule 1 of the Fisheries (General) Regulations 2000, but only insofar as the exemption holder shall not be guilty of an offence when using the number and type of devices specified in Schedule 1 for the purpose of fishing for carp (Family Cyprinidae) from waters of Valley Lake, (Mount Gambier), (the 'exempted activity'), subject to the conditions specified in Schedule 2, from the date of gazettal of this notice until 30 June 2004, unless varied or revoked earlier.

SCHEDULE 1

10 x drum nets

5 x dip nets 2 x drag nets

SCHEDULE 2

- 1. All species other than carp (Family Cyprinidae) taken in the course of the exempted activity must be immediately returned to the water, unencumbered in any way and with as little injury as possible.
- 2. The exemption holder may use up to 4 agents to assist him in undertaking the exempted activity. Any agent assisting the exemption holder must be within 200 m of the exemption holder at any time whilst undertaking the exempted activity.
- 3. The exemption holder must not leave any device unattended for a period longer than $24\ \text{hours}$.
- 4. The exemption holder must remove all fish and all non-fish material from the devices at least once in every 24 hour period.
- 5. At least 24 hours prior to undertaking the exempted activity pursuant to this notice, the exemption holder must advise PIRSA Fisheries Compliance on 1800 065 522 with details of the proposed locations, the dates on which the collections are to be made and names of any agents.
- 6. The exemption holder must provide a report in writing to the Director of Fisheries, (Attention: Roger Hill, P.O. Box 282, Port Adelaide S.A. 5015) within 3 months of the expiry of this notice, providing details of the date, time and location of each occasion that the exempted activity was undertaken and the number of fish collected on each occasion.
- 7. Whilst engaged in the exempted activity the exemption holder must have in his possession a copy of this notice and produce a copy of the notice if required by a PIRSA Fisheries Compliance Officer.
- 8. The exemption holder must not contravene or fail to comply with the Fisheries Act 1982, or any regulations made under the Act, except where specifically exempted by this notice.
