NOTICE is hereby given that the Minister for Urban Development and Planning has, pursuant to sections 24 and 26 of the Development Act 1993, prepared a draft Plan Amendment Report (PAR) to amend the Development Plan for the City of Onkaparinga.

The draft PAR proposes to amend development policy by rezoning approximately 190 hectares of land at Aldinga Beach and Sellicks Beach within the Residential Zone to Urban Zone. In addition, new policies will apply in the affected parts of the Urban Zone to ensure land division does not occur prematurely, ahead of the appropriate provision of infrastructure.

The draft PAR will be on public consultation from 26 March 2004 to 26 May 2004.

Copies of the draft PAR are available during normal office hours at the Department for Transport and Urban Planning (Planning SA), Level 5, 136 North Terrace, Adelaide, or can be viewed on the Internet at:

Written submissions regarding the draft PAR should be submitted no later than 5 p.m. on 26 May 2004. Box 1815, Adelaide, S.A. 5001 and should clearly indicate whether you wish to be heard in support of your submission at the public hearing. Copies of all submissions will be available for inspection by interested persons at Planning SA, Level 5, 136 North Terrace, Adelaide, from 27 May 2004 until the conclusion of the public hearing.

A public hearing will be held on Tuesday, 8 June 2004 at 7 p.m. at the Seaford Hotel, Upstairs Function Room, Corner Commercial Road and Griffiths Drive, Seaford, at which time interested persons may be heard in relation to the draft PAR and the submissions. The public hearing will not be held if no submissions are received or if no submission makes a request to be heard.
