Notice Fixing Charges for Full Fee Paying Overseas Students

PURSUANT to Section 106B of the Education Act 1972, I fix the following charges payable by a full fee paying overseas student (defined in Section 72I of the Education Act 1972) of a Government school commencing school year 2012:

2. Tuition charge for student enrolled for whole school year:	
(a) if the student is a dependant of a person who holds a temporary visa under the Migration Act 1958, of the Commonwealth and who is participating in tertiary education:	
(i) for tuition in primary courses	3 780

- (ii) for tuition in secondary courses or in an intensive English course at secondary level 4 700
- (b) in any other case:
- (i) for tuition in primary courses or in an intensive English course at primary level 8 400
- (ii) for tuition in secondary courses or in an intensive English course at secondary level:
- (A) for years 8 to 10 10 000
- (B) for years 11 to 12 11 000

3. Tuition charge for student enrolled for part of school year—If a student is enrolled at a Government school for part of a school year, the tuition charge is:

- (a) a proportion of the tuition charge that would be payable if the student were enrolled for the full school year, being the proportion that the number of school terms for the whole or part of which the student is enrolled bears to 4; plus
- (b) if the student is enrolled in primary or secondary courses for a period of less than 10 weeks and the student is not a dependant of a person who holds a temporary visa under the Migration Act 1958, of the Commonwealth and who is participating in tertiary education, \$25 for each week for which the student is enrolled.

FISHERIES MANAGEMENT ACT 2007: SECTION 115

TAKE notice that pursuant to Section 115 of the Fisheries Management Act 2007, the holder of a Prawn Fishery Licence issued pursuant to the Fisheries Management (Prawn Fisheries) Regulations 2006, for the Gulf St Vincent Prawn Fishery listed in Schedule 1 (the 'exemption holders'), or their registered masters, are exempt from the notices made under Section 79 of the Fisheries Management Act 2007, prohibiting the taking of King Prawn (*Merlicertus latisulcatus*) but only insofar as the exemption holders shall not be guilty of an offence when using prawn trawl nets in accordance with the conditions of their fishery licence for the purpose of stock assessment survey (the 'exempted activity'), subject to the conditions contained in Schedule 2.

2. All trawling activity must be completed by 0700 hours on each day with nets out of the water.

3. The exemption holder must comply with instructions from the SARDI Stock Assessment Co-ordinator and work within the allotted survey trawl stations.

4. All fish, other than King Prawns, Southern Calamari (*Sepioteuthis australis*) and Bugs (*Ibacus spp.*) taken during the exempted activity for stock assessment purposes, are to be returned to the water immediately after capture, other than species taken as by-catch that are collected, bagged and labelled according to instructions from a SARDI Survey Co-ordinator.

5. Any by-catch species taken in accordance with Clause 4 must be supplied to a SARDI Survey Co-ordinator and removed from the boat by SARDI prior to the boat undertaking any other fishing activity. Any by-catch must not be retained by the exemption holder, their agent, crew or any other person.

6. King Prawns, Southern Calamari and Bugs taken pursuant to the exempted activity must be disposed of by the exemption holders in accordance with the 'GSV Prawn Fishery Survey Participation Agreement' and must not be retained by the exemption holder, their agent, crew or any other person.

7. While engaged in the exempted activity or while unloading the survey catch, the exemption holder must have on board their boat or near their person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer if requested.

8. The exemption holder must not contravene or fail to comply with the Fisheries Management Act 2007, or any other regulations made under that Act except where specifically exempted by this notice.

FISHERIES MANAGEMENT ACT 2007: SECTION 115

TAKE notice that, pursuant to Section 115 of the Fisheries Management Act 2007, Ben Smith of Southern Australian Seafood's (the 'exemption holder') of Aquaculture Licence FT00620, Section 104, Hundred of Louth, P.O. Box 2516, Port Lincoln, S.A. 5606 is exempt from Sections 52, 53 and 70 of the Fisheries Management Act 2007, but only insofar as he may take Greenlip Abalone (*Haliotis laevisgata*) for aquaculture broodstock (the 'exempted activity') in the waters specified in Schedule 1, subject to the conditions in Schedule 2 from 20 April 2011 until 23 March 2012, unless varied or revoked earlier.

2. All Abalone broodstock taken pursuant to this exemption must be delivered to and retained at a controlled room at Southern Australian Seafood's Aquaculture Licence FT00620, Section 104 Hundred of Louth.

3. No specimens taken pursuant to this exemption can be sold or transferred to another party.

4. The exempted activity may also be conducted on the exemption holder's behalf by Andrew Christian.

5. Broodstock taken under this exemption must be physically contained and separated from any farm-reared and growout animals, including ensuring that there is no mixing of water used to hold wild-caught broodstock with areas used to hold growout stock.

6. Broodstock taken pursuant to this exemption must be held together in identifiable groups from specific geographic locations or if broodstock from different areas must be mixed due to on-farm logistics, broodstock must be tagged so that their date and location of capture can be determined.

7. The exemption holder or agent must notify PIRSA Fishwatch on 1800 065 522 at least two hours prior to conducting the exempted activity and answer a series of questions about the exempted activity. The exemption holder will need to have a copy of the exemption at the time of making the call, and be able to provide information about the area and time of the exempted activity, the vehicles and other related questions. 8. The exemption holder must provide a written report to the Executive Director Fisheries and Aquaculture at (G.P.O. Box 1625, Adelaide, S.A. 5001) within 14 days of any collection. The report is to provide details of the time, date, location and number of fish collected, including details of any mortalities.

9. The exemption holder must provide a written report to the Executive Director Fisheries and Aquaculture at (GPO Box 1625, Adelaide, S.A. 5001) within one month of the expiry of this notice and provide a report detailing a summary of the broodstock collected including the time, date, location and number of fish collected, including details of any mortalities along with a summary report of any outcomes of the breeding program during the period of the exempted activity.

10. While engaged in the exempted activity the exemption holder must carry or have about or near their person a copy of this notice. Such notice must be produced to a PIRSA Fisheries Officer upon request.

The increase in land tax collections, between the first six months of 2010-11 and the corresponding period in 2009-10, mainly reflects growth in land values. December quarter land tax receipts are typically higher than other quarters, as taxpayers, who pay annually, generally pay a single amount in either the December or March quarters.

Payroll tax receipts for the December quarter 2010 were higher than the December quarter 2009, reflecting growth in taxable payrolls.

Stamp duty receipts for the December quarter 2010 were higher than in the December quarter 2009, mainly due to the receipt of conveyance duty payments.

Fees and Charges

The increase in fees and charges, between the first six months of 2010-11 and the corresponding period in 2009-10, mainly reflects the increase in the receipt of guarantee fees.

Commonwealth – General Purpose Grants

Growth in general purpose grants, between the first six months of 2010-11 and the corresponding period in 2009-10, is not indicative of underlying Goods and Services Tax (G.S.T) revenue growth. Monthly grants are paid according to a payment schedule prepared by the Commonwealth Government at the commencement of a financial year, rather than in accordance with the actual monthly G.S.T collections.

In the Commonwealth's 2010-11 Mid-Year Economic and Fiscal Outlook, the Commonwealth Government assumed the G.S.T pool would grow by 6.65% in 2010-11.

Commonwealth – Specific Purpose Grants and National Partnership Payments

Specific purpose and National Partnership grants, for the December quarter 2010, are lower than the corresponding period in 2009, as the December, 2009 quarter included grants relating to four months, including September, 2009. National Partnership payments for the six months to December, 2010 are lower than the corresponding period in 2009, following the cessation of the Commonwealth's First Home Boost Scheme in December, 2009.

Payments

Payments were made pursuant to the *Supply Act 2010*, for the period from 1 July 2010 until assent was given to the *Appropriation Act 2010* on 18 November, 2010, and also in accordance with various other Acts for which specific appropriation has been authorised.

Payments made from the Consolidated Account, for the December quarter, were higher than the same period in 2009-10, due mainly to the timing of the past service superannuation payment.

Note

Considerable caution should be exercised in interpreting the quarterly statement of Consolidated Account transactions. Unlike the State budget, which comprises transactions on an accrual basis, the information reflected in the quarterly statements is limited to cash transactions. In addition, the Consolidated Account does not capture all the transactions undertaken by the general government sector (in particular, it does not record receipts to and payments from special deposit accounts). Finally, it should be noted that, the timing of receipts and payments could be volatile within a particular year. As a result, apparently significant movements between years may only be due to changes in the timing of receipts and payments, and, therefore, may not have implications for the underlying budget position.
