#### **ENVIRONMENT PROTECTION ACT 1993**

#### Approval of Category B Containers

I, ANDREA KAYE WOODS, Team Leader, Container Deposit Legislation and Delegate of the Environment Protection Authority ('the Authority'), pursuant to Section 68 of the Environment Protection Act 1993 (SA) ('the Act') hereby:

#### Approval of Category B Containers

Approve as Category B Containers, subject to the conditions in subclauses (1), (2), (3) and (4) below, each of the classes of containers identified by reference to the following matters described in the first 4 columns of Schedule 1 of this Notice which are sold in South Australia:

- (a) the product which each class of containers shall contain;
- (b) the size of the containers;
- (c) the type of containers; and
- (d) the name of the holders of these approvals.
- (1) That containers of the class to which the approval relates must bear the refund marking specified by the Authority for containers of that class. The autority specifies the following refund markings for Category B containers:
  - (a) '10c refund at collection depots when sold in SA'; or
  - (b) '10c refund at SA/NT collection depots in State/Territory of purchase'.
- (2) The holder of the approval must have in place an effective and appropriate waste management arrangement in relation to containers of that class. For the purpose of this approval notice the company named in Column 5 of Schedule 1 of this Notice is the nominated super collector.
- (3) In the case of an approval in relation to Category B containers that the waste management arrangement must require the holder of the approval to provide specified super collectors with a declaration in the form determined by the Authority in relation to each sale of such containers by the holder of the approval as soon as practicable after the sale.
- (4) The holder of these approvals must ensure that if a sticker bearing the refund marking has been approved, and is applied to the container, then the sticker must not be placed on any portion of the opening mechanism or in any other place that would require complete or partial removal of the sticker before the contents may be consumed.

## DETERMINATION OF THE REMUNERATION TRIBUNAL OF SOUTH AUSTRALIA

No. 1 of 2012

Members of Parliament Travel Entitlement and Rules

#### INTRODUCTION

1. Scope of Determination

The Determination applies to a Member of the Parliament of South Australia.

2. Members of Parliament Travel Entitlement and Rules

A Member shall be entitled to an entitlement in respect of travel, as set out in this Determination.

#### ENTITLEMENT AND RULES

#### 1. Definitions

For the purposes of the Entitlement and Rules part of this Determination:

- (a) 'Basic Allowance' in relation to any year means the Basic Allowance of a Member determined in accordance with Rule 3.
- (b) 'Domestic partner' means a domestic partner of a Member as defined in the Members of Parliament (Register of Interests) Act 1983.
- (c) 'Domestic travel' means travel within South Australia or Australia, but for House of Assembly Members does not include travel within their electorate.
- (d) 'Member' means a Member of the Legislative Council or the House of Assembly, and includes the Presiding Officers and Ministers of the Crown.
- (e) 'Presiding Officer' means the Speaker of the House of Assembly or the President of the Legislative Council.
- (f) 'Remuneration Tribunal' means the Remuneration Tribunal as established by the Remuneration Act 1990.
- (g) 'Spouse' means the spouse of a Member as defined by the Members of Parliament (Register of Interests) Act 1983.
- (h) 'Year' means the period commencing on 1 July and ending on the subsequent 30 June.

#### 2. Entitlement

- (1) Subject to these rules, every Member shall be entitled to expend on:
  - (a) domestic travel; and
  - (b) overseas travel;

- an amount up to but not exceeding the amount of the Basic Allowance which is available to the Member at the date of travel.
- (2) Such expenditure may be incurred for the purpose of undertaking studies and investigations of matters of interest, attending conferences, meetings, community events or other events related to his or her duties and responsibilities as a Member of Parliament or which involve the Member because he or she is a Member of Parliament.

#### 3. Basic Allowance

- (1) The Basic Allowance for 2011-2012 shall be \$12 500.
- (2) For subsequent years the Basic Allowance shall be a sum (calculated to the nearest multiple of \$100) that bears to \$12 500 the same proportion as the Consumer Price Index for Adelaide June quarter of the immediately preceding year bears to the Consumer Price Index for Adelaide for the June quarter, 2011.
- (3) Any Basic Allowance not expended in a given year may be carried forward to the next succeeding year but any part of the Basic Allowance, which is not spent in the second year, shall be forfeited.
- (4) Paragraph (3) of this rule shall apply to and include an amount carried forward into the financial year 2011-2012.
- (5) The annual entitlement of a Member shall become available in full to the Member on 1 July each year. Where a Member is elected for the first time (or is re-elected following a break of service) then if the Member is elected between 1 July and 31 December, he or she shall be entitled to the full Basic Allowance for that year. If the Member is elected between 1 January and 30 June, he/she shall be entitled to 50 per cent of the Basic Allowance for that year.

#### 4. Credit in Advance

- (1) A Member may at any time obtain funding in advance against the prospective entitlement of the Member for the next succeeding year. The amount available shall not exceed the amount available in respect of the current year. Any additional entitlement, which may be determined as a result of any alternation to the Basic Allowance, shall become available to the Member on 1 July in the next succeeding year.
- (2) Expenditure against a Member's entitlement shall be charged against the oldest balance of entitlement first.

#### 5. Expenses

Subject to these rules, the Basic Allowance may be expended on scheduled domestic travel or overseas travel services of any kind (including hire cars, taxis and chartered services). The Basic Allowance may also be expended on conference or seminar fees when associated with a travel claim under these rules

#### 6. Spouse or Domestic Partner

- (1) Travel expenses incurred by a spouse or domestic partner when accompanying a Member may in approved circumstances be charged to the Basic Allowance.
- (2) No more than half of the Basic Allowance shall be expended on the travel of a Member's spouse or domestic partner.
- (3) Where the Member is accompanied by a member of his or her staff in lieu of a spouse or domestic partner, the charge to the Basic Allowance shall be subject to the same limit as applies under paragraph (2) of this rule.
- (4) The circumstances in respect of which the Presiding Officer may approve of the travel expenses of a spouse or domestic partner being a charge to the Basic Allowance are where the Member's spouse or domestic partner is formally invited to attend an official community event in South Australia or parliamentary function in South Australia, Australia or overseas, with the Member.

(5) No approval from the Presiding Officer is required where the Member is accompanied by a member of his or her staff in lieu of a spouse or domestic partner unless the member of staff is also a spouse or domestic partner, in which case the requirements of paragraph (4) of this rule applies.

#### 7. Extraordinary Circumstances

- (1) Where a Member has special physical or medical needs that require assistance to enable the Member to undertake domestic or overseas travel, the Member may apply in writing to the Remuneration Tribunal for approval for the cost of a carer's travel expenses to be charged to the Basic Allowance.
- (2) The maximum charge available under paragraph (1) of this rule will be no more than half of the Basic Allowance.
- (3) Where a Member's spouse or domestic partner or member of staff has special physical or medical needs that require assistance to enable him or her to undertake domestic or overseas travel, the Member may apply in writing to the Remuneration Tribunal for approval for the cost of a carer's travel expenses to be charged to the Basic Allowance.
- (4) Any approval of the Remuneration Tribunal granted in terms of this rule must be provided by the Remuneration Tribunal in writing to the applicant, and such letter of approval shall be evidence that the travel expenses will be a charge on the Member's Basic Allowance in accordance with these rules.
- (5) The maximum charge available under paragraph (3) of this rule will be no more than half of the Basic Allowance.

#### 8. Application for Travel and Per Diem Allowance

- (1) Any application for per diem allowance in Australia or overseas, and application for travel shall be submitted in writing to the relevant Presiding Officer in the form as approved by the Presiding Officers, and shall contain the following information:
  - (a) a proposed itinerary (which clearly indicates the number of days to be spent on Parliamentary business); and
  - (b) a statement of objectives for the proposed travel.
- (2) Where the approval of the relevant Presiding Officer has been obtained, Members are not required to seek approval of variations in the proposed itinerary other than those which are of significance.
- (3) Where an application is made for travel expenses of a spouse or domestic partner to be met from the Basic Allowance, the application for travel shall include satisfactory evidence that the Member and spouse or domestic partner have been formally invited to a parliamentary function or community event.
- (4) When a staff member accompanies a Member on travel, the conditions of travel and per diem allowance claimed by the staff member against the Basic Allowance should be the same as if the staff member were a public servant travelling with the Member.

#### 9. Per Diem Overseas

- (1) Where a Member travels overseas, the Member shall be entitled to claim against the Basic Allowance a per diem allowance, provided that no such allowance shall be claimed in respect of any other person accompanying the Member, other than a staff member who is not the Member's spouse or domestic partner.
- (2) The amount of the per diem allowance is an amount equal to 125 per cent of the daily allowance fixed in respect of Ministers of the Crown travelling interstate, as determined from time to time by the Remuneration Tribunal.

#### 10. Per Diem within Australia

Where a Member undertakes domestic travel, then the Member shall be entitled to claim against the Basic Allowance a per diem allowance equal to the amount available to Ministers of the Crown who travel within Australia on official business as determined from time to time by the Remuneration Tribunal. No such allowance shall be claimed in respect of a person, other than a staff member who is not the Member's spouse or domestic partner, who travels with the Member.

#### 11. Fringe Benefits Tax Declaration

- (1) Where a Member travels overseas, he or she shall execute and lodge, with the Clerk of the House of which he or she is a Member, a declaration in the form as approved by the Presiding Officers.
- (2) In the event of a declaration being subsequently disallowed by the Australian Taxation Office, or if a Member has not lodged a declaration within 60 days of his or her return to Australia, the Member shall be required to repay in full the expenditure to which the declaration relates, before any further entitlement may be expended.

#### 12. Repayment

- If a Member shall die or for any other reason shall cease to be a Member of the Parliament, then the Member shall not be required to repay any part of the Basic Allowance in respect of the current year.
- (2) Where the Member has received an advance against the entitlement of a future year, then the Member or his or her legal personal representatives shall make arrangements with the appropriate Presiding Officer to repay the amount of the advance in full.
- (3) Where a Member has received a per diem allowance and dies or returns early from domestic or overseas travel, then the Member or his or her legal personal representatives shall make arrangements with the appropriate Presiding Officer to repay the overpaid per diem allowance.

#### 13. Report

- (1) Where a Member claims an allowance for themselves and/or a travelling companion for scheduled overseas travel of any kind or per diem allowance of more than three nights duration in respect of domestic travel, the Member shall prepare and deliver a report to the appropriate Presiding Officer for lodgement with the appropriate Clerk of either House of Parliament within 90 days of the completion of the travel to which the report relates.
- (2) The report shall include:
  - (a) a statement of the objectives of the Member's travel;
  - (b) the names of organisations or Parliaments visited;
  - (c) reference to any documents or publications obtained or considered to be of interest as a Member of Parliament;
  - (d) brief summaries of the study areas pursued in the places visited;
  - (e) a summary of the results achieved; and
  - (f) any recommendations arising from the travel.
- (3) If the report is not delivered to the Presiding Officer within 90 days, or if the Presiding Officer is not satisfied that the requirements of these rules (including Rule 2(2)) have been met, no further entitlements may be expended (for travel of any kind) until a report is delivered and the Presiding Officer is so satisfied. For the purpose of being so satisfied the Presiding Officer may require a Member to provide a statutory declaration on the matters in respect of which the Presiding Officer remains to be satisfied.

#### 14. Bookings

(1) Except as expressly provided herein, all travel arrangements shall be made through the Government appointed travel agency and a Member shall not be paid any per diem allowance unless a booking has been made with the Government-appointed travel agency or the Presiding Officer is satisfied the Government-appointed travel agency cannot complete the travel arrangements and has given approval for the Member to make alternative arrangements.

- (2) Where the Government-appointed travel agency is unable to complete the travel arrangements requested by the member prior to the Member's departure, then with the prior approval of the appropriate Presiding Officer, the Member may make alternative arrangements.
- (3) Where the Member is required to vary or undertake further travel arrangements whilst outside of South Australia and it is not reasonably practicable to have made such travel arrangements prior to the Member's departure from South Australia, the Member may make such travel arrangements other than through the Government-appointed travel agency provided that where the Member, following completion of travel, subsequently claims the cost of such travel against the Basic Allowance, the Member shall first produce the used travel coupons to the appropriate Presiding Officer.

#### 15. Amount Available

As soon as practicable after 1 July in any year, the Clerk of each House shall inform each Member of the entitlements available to the Member pursuant to these rules.

#### 16. Declaration

Upon the election or re-election of each Member and before any part of the Basic Allowance is made available, each Member shall execute and lodge with the Clerk of the House of which he or she is a Member, a Declaration in the form as approved by the Presiding Officers stating that he or she has read, understood, and shall comply with the rules.

#### 17. Gold Pass

- (1) Every Member shall be entitled to the continued use of the Gold Pass for travel on trains, buses, trams and any Government owned transport throughout Australia. The benefits of the Gold Pass shall only be applicable to the Member personally and not to any person accompanying the Member.
- (2) Every Member shall be entitled to the provision of travel throughout Australia on rail transport that is Government owned or privately owned by Great Southern Railways. Either a Member's spouse or domestic partner, when travelling to the other States is entitled to two (2) return journeys in a Calendar Year.
- (3) In accordance with the service provider's conditions of booking, a cancellation fee may apply and in such cases Members are responsible for the payment of those fees.

#### OPERATIVE DATE

- 1. This Determination shall operate on and from 9 March 2012.
- 2. Any travel arrangements that were approved by a Presiding Officer on or before 9 March 2012, will be taken to be an approval for the purposes of the entitlement and rules contained in this Determination, notwithstanding that approval had been given in accordance with the Members of Parliament Travel Rules that applied before this Determination.

#### REMUNERATION TRIBUNAL OF SOUTH AUSTRALIA

REPORT RELATING TO DETERMINATION NO. 1 OF 2012

Members of Parliament Travel Entitlement and Rules

#### 1. Introduction

- 1.1 Section 4 of the Parliamentary Remuneration Act 1990, sets out the basis of the remuneration payable to a Member of the Parliament of South Australia. In particular, subsection (1) (c) provides that the remuneration of a Member comprises in part 'such electorate allowances and other allowances, expenses and benefits as are determined from time to time by the Remuneration Tribunal'.
- 1.2 Section 8 (1) of the Remuneration Act 1990, provides that 'a sitting of the Tribunal may be convened by the President of the Tribunal of his or her own motion or at the request of the Minister'.

- 1.3 On 14 November 2011, the Premier, who is the Minister responsible for the *Remuneration Act 1990*, wrote to the President of the Remuneration Tribunal ('the Tribunal'), and pursuant to Section 8 (1) of the Remuneration Act 1990, requested that the Tribunal convene a sitting and make a determination regarding those aspects of the travel allowance provisions that provide for a member's spouse, partner or family member to accompany them on parliamentary travel.
- 1.4 The Premier included a copy of the Members of Parliament Travel Entitlement Rules (as amended at 20 November 2008) which until this determination of the Tribunal were a set of rules approved by the Government. The Premier's letter asked that the Tribunal consider the existing rules relating to the entitlements for a spouse, domestic partner, or family member to accompany the Member on travel for parliamentary purposes, and issue a determination based on the outcome of the Tribunal's review and deliberations.
- 1.5 On 10 December 2011, a notice was published in *The Advertiser* newspaper, advising the general public that following a request from the Premier, the Tribunal was to conduct a review of the Parliament Travel Entitlement Rules, with particular attention being given to a review of the rule that permitted a spouse, domestic partner or family member to accompany a Member of Parliament on his or her domestic travel or overseas travel for parliamentary purposes. In his letter to the Tribunal, the Premier advised that there was clearly 'community concern' about the existing rule that permitted a spouse, domestic partner or family member, to have their travel expenses met from the Member of Parliament's travel allowance. The public notice invited submissions to the review from interested persons, organisations and associations.
- 1.6 The Tribunal also wrote to and invited both written and oral submissions from the following:
  - · the Premier,
  - the Leader of the Opposition,
  - the Leader of the Family First Party of South Australia,
  - the Leader of The Greens SA, and
  - all current Members of the Parliament of South Australia.
- 1.7 As a follow up to the submissions received from the Premier, the Liberal Party of S.A., and four individual Members of Parliament, the Tribunal wrote to these persons and bodies on 7 February 2012, seeking any further comment with regards to the Members of Parliament Travel Entitlement Rules as a whole. This subsequent invitation to the political entities who had already made submissions was a decision of the Tribunal which considered it appropriate to inform these entities that based on its statutory powers, the Tribunal was in fact reviewing all the rules as part of its deliberations before issuing a determination in terms of Section 4 (1) (c) of the Parliamentary Remuneration Act.

#### 2. Submissions

- 2.1 The Tribunal received ten written submissions; four from individual parliamentarians, three from members of the public and submissions from the South Australian Government, the Liberal Party of S.A. and the Clerk of the House of Assembly of Parliament House. The Tribunal also received two supplementary submissions.
- 2.2 The Tribunal convened on 30 January 2012 and on 27 February 2012, to consider the submissions and to hear one oral submission.
- 2.3 The submissions received were generally supportive of maintaining the provision for a spouse (or domestic partner) to accompany a Member on parliamentary travel, but were not supportive of another family member, in particular children, accompanying a Member on parliamentary travel.
- 2.4 There was no opposition to a staff member accompanying a Member on parliamentary travel in the submissions to the Tribunal.

- 2.5 The following points were raised in submissions in support of a spouse and domestic partner accompanying a Member of Parliament on his or her travel:
  - —The company of a spouse (or domestic partner) on parliamentary travel provides benefits to the Member, including; increased security, rather than travelling alone; additional knowledge if a spouse (or domestic partner) has special language skills or knowledge or previous experience of the location.
  - —Due to the nature of their work, Members are often absent from their family for long periods, especially country Members. In addition technological advancements and the public's need for information have resulted in a Member's role changing significantly. Members are often effectively 'on-call' at all times for electorate matters. The travel provision can assist to ease the strain on Members' personal relationships, and maintain greater work/life balance, by allowing the Member to spend time with their spouse (or domestic partner).
  - —A spouse (or domestic partner) is often part of the public face of the Member. Hosts often expect that a spouse (or domestic partner) will accompany a Member at functions and events. Attendance of a spouse (or domestic partner) at such proceedings can communicate to hosts and the community that the Member considers the event to be important, and can often improve interaction of individuals.
- 2.6 The following points were raised in submissions in opposition to a spouse, domestic partner or family member accompanying a Member of Parliament on his or her travel:
  - —The responsibility of childcare whilst on parliamentary travel is an unnecessary distraction for the Member, particularly during 'working hours' when it would be expected that the Member would be focussed on parliamentary matters and functions. In such circumstances the Member would either be responsible for care of the child, or the responsibility would fall to another individual.
  - —The benefit to a Member of Parliament in their role as a parliamentarian or the benefit to the electorate, of a child's presence on parliamentary travel is questionable. As it is tax-payer funded, it is important that the funds are spent in a manner that provides a direct benefit to the Member in their role as a parliamentarian, to the electorate or to the South Australian people.
  - —The lack of transparency regarding the benefit provided by a child or family member's presence during parliamentary travel has led to the public's loss of confidence in the rationale for the travel. Greater transparency should be implemented to more clearly indicate how the presence of the spouse will assist the Member in their role as a parliamentarian, or will benefit South Australians in general.
  - —While the need for Members to maintain a good work/life balance and healthy personal relationships is recognised, it is questionable if the spouse (or domestic partner) or family member travel provisions are the most effective and appropriate way to combat the impact of the role and the Members' absences.
  - —Such provisions do not exist in other occupations or industries for individuals in roles of similar status.
- 2.7 A number of submissions advocated that provision should be made for an independent arbiter to determine on the merits of the case, whether approval be granted for payment of the travel expenses of a spouse or domestic partner, or where appropriate a family member. Appropriate circumstances could relate to the visit itself, the particular circumstances of the individual Member, the spouse (or domestic partner) or the family member, or the general personal circumstances of the Member and their family.

- 2.8 It was suggested that special circumstances could also relate to the mobility or sensory needs of the Member or the spouse (or domestic partner), or family member, the personal or medical circumstances relating to the Member, or any unforeseen circumstances that arise close to the time of the planned travel.
- 2.9 The submissions argued that any discretion must be balanced by the need for transparency and accountability for public funds, for example, requiring strict guidelines for approval and reporting.
- 2.10 It was also submitted that the Tribunal review and consider the appropriateness of continuing the 'Gold Pass' entitlement, particularly in view of the relative cost of air and rail travel.
- 2.11 One submission brought to the Tribunal's attention a number of provisions in the existing rules that were either unclear or open to different interpretation.

#### 3. Interstate Provisions

- 3.1 The Tribunal researched the travel arrangements that apply in each of the different Australian jurisdictions and found that the arrangements that applied varied significantly from jurisdiction to jurisdiction, particularly in relation to the rules. Whilst not all jurisdictions provide an automatic travel allowance provision, the Tribunal did find that there was a reasonable closeness in the quantum of the travel allowance between South Australia and several other States.
- 3.2 The Tribunal found that in terms of the eligibility and the rules relating to a spouse, domestic partner or family member accompanying a Member of Parliament on parliamentary travel, the arrangements varied widely.
- 3.3 There is no general standard for the provision of an entitlement for, or the sharing of a parliamentarian's travel allowance with a spouse, domestic partner or family member. However in most jurisdictions, but not all, some provision is made for a spouse or a family member to accompany a Member on parliamentary travel. Where an eligibility exists, some jurisdictions have more stringent rules than others.

#### 4. Fair Work Act 1994 (S.A.)

4.1 The Tribunal, as required by Section 101 (1) of the Fair Work Act 1994 (S.A.) has in this matter, and continues to have, due regard to the Wage Fixing Principles, and as it deems appropriate to apply and give effect to such principles in this Determination.

#### 5. Operative Date

- 5.1 As this is the first time the Tribunal has considered the provisions currently established under the *Members of Parliament Travel Entitlement Rules*, it has determined that a retrospective operative date is not appropriate.
- 5.2 Accordingly, the Tribunal has considered the submissions made and determined an operative date of 9 March 2012, for Determination 1 of 2012.

#### 6. Discussion

- 6.1 The Tribunal has recognised the need for the provision of transparent and accountable travel in all situations where travel is undertaken in respect of parliamentary service at taxpayer expense.
- 6.2 The Tribunal has had regard to all the submissions and material before it, including information regarding current interstate provisions for taxpayer financed travel for a spouse, domestic partner or family member.
- 6.3 In light of the information before the Tribunal, it has determined that it was appropriate for a number of changes to be made to the provisions contained in the Members of Parliament Travel Entitlement Rules as presented to the Tribunal. The Tribunal has therefore issued the new Members of Parliament Travel Entitlement and Rules in its Determination 1 of 2012.

- 6.4 The Tribunal came to the conclusion that it was no longer appropriate for an immediate family member to accompany a Member on parliamentary travel in lieu of a spouse or domestic partner at taxpayer expense. Accordingly, the previous entitlement for a family member in lieu of a spouse or domestic partner has been removed.
- 6.5 The Tribunal did find however, that there were certain situations where it was appropriate for a Member to have the travel expenses of his or her spouse or domestic partner met from the Member's travel allowance. The Tribunal noted that in terms of the existing rules presented to the Tribunal for review, a Member could have the travel expenses of his or her spouse or domestic partner met from the Member's travel allowance as of right. The only restriction was that no more than 50% of the Member's travel allowance could be applied to the travel expenses of his or her spouse or domestic partner.
- 6.6 The Tribunal has determined that there needs to be more transparency and justification for a spouse or domestic partner accompanying a Member who travels as part of their parliamentary work and service at taxpayer expense. For this reason, the Tribunal has determined that the travel expenses of a spouse or domestic partner can only be met from the Member's travel allowance where the spouse or domestic partner has been formally invited to accompany the Member to a community function in South Australia, or a parliamentary function. It is considered appropriate that the travel expenses of a spouse or domestic partner be met where there is an expectation that a spouse or domestic partner will accompany the Member to such an event, when the spouse or domestic partner has been formally invited. The current limitation that no more than 50% of the Member's travel allowance may be expended on a spouse or domestic partner's travel expenses has been retained.
- 6.7 The Tribunal has included a provision for a discretionary approval power, exercisable by the Tribunal, to allow up to 50% of the Member's travel allowance to be expended on someone other than the Member's spouse or domestic partner, but in special circumstances only. These special or Extraordinary Circumstances, as the new rule is termed in the Determination, are those where the Member or the Member's spouse or domestic partner or member of staff have special physical or medical needs that require assistance to enable the Member or the Member's spouse or domestic partner or member of staff to undertake approved domestic or overseas travel. A Member with such needs will be able to apply to the Tribunal for approval for the cost of a carer's travel expenses to be charged to the Member's travel allowance. A limit of 50% of the travel allowance applies to the expenses that may be charged under this new special circumstances rule.
- 6.8 The Tribunal has removed reference to 'a nominated family member of his or her immediate family' from the previous Gold Pass rule. In light of the limited use of this provision by family members, and the current cost of rail travel, the Tribunal is of the view that this entitlement be limited to the spouse or domestic partner of the Member. The Tribunal received views in the submissions supporting this new position.
- 6.9 In addition, it is the Tribunal's intention to review the Gold Pass provisions set out in Rule 17 between now and the next review of this Determination as required by statute. After considering the Gold Pass rule at the current time, the Tribunal notes that in the context of the cost of comparable rail and air travel in Australia and the associated travel time, it is difficult to justify an arrangement whereby taxpayers meet the cost of a form of travel that is more expensive than air travel.

- 6.10 A number of Schedules were referenced in the original Members of Parliament Travel Entitlement Rules. The Schedules assisted in the day-to-day administration of the Rules. In the interests of administrative efficiency, references to the Schedules have been replaced with references to an administrative manner and form as determined by the appropriate Presiding Officer.
- 6.11 The Tribunal has reviewed the entitlement of the aspect of the rules as requested by the Premier. It has also reviewed the existing entitlement and the remainder of the rules as presented to the Tribunal. Not only did the Tribunal have the statutory powers to review the entitlements and rules before issuing a Determination, it considered it had a responsibility to do this. As a consequence, Determination 1 of 2012 has made many changes of a minor nature to the wording in the existing provisions. Whilst most of these changes do not alter the existing policy, the Tribunal believed the changes were necessary to provide clarity and remove the possibility of the intention of the rules being open to alternative interpretation.

#### 7 Conclusion

7.1 Having had regard to all the submissions and material before it, the Tribunal has determined that the *Members of Parliament Travel Entitlement Rules* as provided to the Tribunal by the Premier on 14 November 2011, be replaced with its Determination 1 of 2012, in the terms expressed in that Determination, and for the reasons set out in this Report

#### **ROAD TRAFFIC ACT 1961**

Pursuant to Sections 161A and 163AA of the Road Traffic Act 1961

## OPERATION OF MOTOR GRADERS TOWING MULTIPLE TRAILERS UP TO 42 M IN LENGTH FOR CONSTRUCTION AND/OR MAINTENANCE OF ROADS IN REMOTE AREAS

#### 1. APPROVAL

1.1 I hereby approve motor graders towing multiple trailers up to an overall length of 42 m, to travel on DPTI roads within remote areas of the Northern and Western region boundaries, for the purpose of construction and/or maintenance of DPTI roads.

#### 2. EXEMPTION

- 2.1 I hereby exempt a motor grader, operating under the terms and conditions of this notice, from the following provisions of the *Road Traffic (Vehicle Standards) Rules 1999*:
  - 2.1.1 Part 5, Division 1, Regulation 27 (4)—Steering;
  - 2.1.2 Part 7, Division 2, Regulation 66 (1)—Width;
  - 2.1.3 Part 8, Division 8, Regulation 94—Vehicles needing side marker lights;
- 2.2 I hereby exempt a motor grader, operating under the terms and conditions of this notice, from the following provisions of the *Road Traffic (Oversize or Overmass Vehicle Exemptions) Regulations 1999*:
  - 2.2.1 Part 3, Regulation 25—Prohibition on towing other vehicles;
- 2.3 I hereby exempt trailers towed in combination with a motor grader, operating under the terms and conditions of this notice, from the following provisions of the *Road Traffic (Vehicle Standards) Rules 1999*:
  - 2.3.1 Part 8, Division 7—Clearance Lights;
  - 2.3.2 Part 8, Division 8—Side Marker Lights;
  - 2.3.3 Part 8, Division 19—Other Lights, Reflectors, Rear Marking Plates or Signals;

**Note:** Trailers are exempt from the above provisions only when used in a motor grader, multi trailer combination, operating under terms and conditions of this notice.

- 2.4 I hereby exempt a motor grader and multi trailer combination, operating under terms and conditions of this notice, from the following provisions of the *Road Traffic (Vehicle Standards) Rules 1999*:
  - 2.4.1 Part 6, Regulation 60 (1)—Warning Signs for combinations over 22 m long;
- 2.5 I hereby exempt a motor grader and multi trailer combination, operating under terms and conditions of this notice, from the following provisions of the *Road Traffic (Oversize or Overmass Vehicle Exemptions) Regulations 1999*:
  - 2.5.1 Part 1, Regulation 3 (1)—Dimension limits;

#### 3. **CONDITIONS:**

- 3.1 The motor grader and multi trailer combination is only permitted to travel on DPTI roads within the boundaries of the Northern and Western region for the purpose of:
  - 3.1.1 Undertaking activities directly involved with road construction and/or maintenance; or
  - 3.1.2 Transport from a place of road construction and/or road maintenance operation to another place of road construction and/or road maintenance.
- 3.2 The motor grader and multiple trailer combination shall not be driven or used on a road or road related area between the hours of sunset and sunrise as specified in the *Proof of Sunrise and Sunset Act 1923*, as amended, and published in the *South Australian Government Gazette*.
- 3.3 The motor grader and multiple trailer combination shall not be driven or used on a road or road related area during periods of low visibility.

**Note:** For the purpose of this notice 'a period of low visibility' means any time when, owing to insufficient daylight or unfavourable conditions, persons or vehicles on a road are not clearly visible at a distance of 250 m to a person of normal vision.

3.4 Travel shall only be permitted within DPTI Northern and Western Region boundaries, North of Port Augusta, North of the Barrier Highway and North of the Eyre Highway.

**Note:** Travel is not permitted across or along the Barrier or Eyre Highways.

- 3.5 The motor grader and multiple trailer combination shall not be operated at a speed exceeding 40 km/h.
- 3.6 That all vehicles in combination shall be appropriately registered (e.g. not registered for use on worksites only).

- 3.7 The sum of the load carrying capacity of tyres fitted to each unit of the combination must match the manufacturer's gross vehicle mass (GVM) or gross trailer mass (GTM) of that vehicle, where applicable. If no GVM or GTM is specified then statutory axle mass limits will apply.
- 3.8 The motor grader and multiple trailer combination shall not exceed statutory axle mass limits.
- 3.9 The motor grader and multiple trailer combination shall not exceed manufacturer's GVM and/or GTM for each vehicle in the combination, where applicable.
- 3.10 Maximum width of the motor grader shall not exceed 2.65 m.
- 3.11 The tow coupling attached to each vehicle in the combination must be of the correct rating for its use in the combination.
- 3.12 When in transit, any road construction equipment (e.g. towed roller) in the combination, must travel without any additional weight added (i.e. no ballast).
- 3.13 The motor grader shall display a warning light or lights (revolving yellow flashing lights) so that the light emanating from at least one of them is clearly visible at a distance of 500 m in any direction and which meet the following specifications:
  - 3.13.1 Emit a rotating, flashing, yellow coloured light;
  - 3.13.2 Flash at a rate between 120 and 200 times per minute;
  - 3.13.3 Have a power of at least 55 watts; and
  - 3.13.4 Not be a strobe light.
- 3.14 Warning light(s) shall be either permanently connected into the electrical system of the vehicle or use standard automotive connectors to allow easy electrical disconnection and removal of the light(s) when not required.
- 3.15 Warning light(s) shall have incorporated into their electrical system, an 'on/off' switch control which is located within easy reach of the driver, when seated in the driving position.

#### The motor grader and multiple trailer combination shall be fitted with:

- 3.16 A 'Long Vehicle' warning sign complying with Part 6, Section 60, Section 61 and Section 62 of the *Road Traffic* (*Vehicle Standards*) *Rules 1999*, that is clearly visible by other road users.
- 3.17 An audible warning device complying with Rule 34 of the Road Traffic (Vehicle Standards) Rules 1999, if the vehicle was manufactured on or after 1 July 1996.
- 3.18 A rear vision mirror or mirrors complying with the requirements of Rules 35 and 36 of the *Road Traffic (Vehicle Standards) Rules 1999*.
- 3.19 Parking lights that operate effectively and clearly visible, if the motor grader and multiple trailer combination is left standing on a road or road related area between the hours of sunset and sunrise or during periods of low visibility.
- 3.20 Clearance lights and side marker lights that operate effectively and clearly visible, when the motor grader and multiple trailer combination is left standing in a road related area between the hours of sunset and sunrise or during periods of low visibility.
- 3.21 Service Brakes:
  - 3.21.1 Operating on four or more wheels and comply with the performance requirements of Rule 128 of the *Road Traffic (Vehicles Standards) Rules 1999*; or
  - 3.21.2 Utilising a vehicular transmission retardation system commonly referred to as a 'hydrostatic braking system', complying with the performance requirements of Rule 128 of the *Road Traffic (Vehicles Standards) Rules* 1999.
- 3.22 A parking brake that operates on at least two wheels and that is capable of holding the vehicle stationary on a 12 per cent gradient.
- 3.23 An actuating mechanism for the parking brake that incorporates a device that prevents accidental release of that mechanism and holds the brake in the applied position unless intentionally released by the driver.

#### Notes:

For the purpose of this notice a vehicle which incorporates a positive transmission locking system that operates by locking two transmission gears together or engaging a transmission parking pawl is deemed to satisfy the requirements of Clauses 3.22 and 3.23 above provided that the mechanism is capable of holding the vehicle stationary on a 12 per cent gradient.

In accordance with Rule 226 of the *Australian Road Rules* a person shall not drive a vehicle with a GVM over 12 tonnes unless the vehicle is equipped with at least three portable warning triangles that must be used in accordance with Rule 227 of the *Australian Road Rules*. If the GVM of the vehicle is not specified, the unladen mass of the vehicle shall apply.

The owner of a motor grader and multiple trailer combination must ensure that all other relevant requirements under the South Australian *Road Traffic Act 1961* and the *Motor Vehicles Act 1959* are met (e.g. registration requirements).

- 4.1 'Motor grader' means a machine with its own motive power, fitted with pneumatic tyres, built to perform road construction and/or maintenance tasks.

- 4.4 'DPTI' means the Department of Planning, Transport and Infrastructure.
