ABORIGINAL LANDS TRUST ACT 2013

Scheme to Call for Expressions of Interest for Appointment to the Aboriginal Lands Trust

PURSUANT to Section 10 (2) of the Aboriginal Lands Trust Act 2013 (the Act), six vacancies will exist within the Aboriginal Lands Trust (the Trust) from 1 July 2017, requiring the call for expressions of interest for appointment to the Trust.

I, the Honourable Kyam Maher, MLC, Minister for Aboriginal Affairs and Reconciliation, hereby give notice that I intend to establish a selection panel for the purposes of recommending persons for appointment to the Trust in accordance with Section 11 of the Act, and publish a Public Notice calling for applications by Aboriginal people interested in being appointed to

The Public Notice will be published in the Advertiser, websites of both the Department of State Development-Aboriginal Affairs and Reconciliation (DSD-AAR) and the Trust, the principal office of the Trust, and provided to a wide range of relevant government and community agencies.

The Public Notice will allow four weeks for responses to be received by DSD-AAR for forwarding to the Selection Panel.

The Selection Panel would have two weeks to deliberate and make their recommendations to the Minister.

The successful applicants will be appointed to the Trust by the Governor, on nomination by the Minister, upon recommendation of the Selection Panel.
