# **Administrative Arrangements (Alteration of Title of Body Corporate) Proclamation 2020**

under sections 7 and 8 of the Administrative Arrangements Act 1994

#### 1—Short title

This proclamation may be cited as the Administrative Arrangements (Alteration of Title of Body Corporate) Proclamation 2020.

#### 2—Commencement

This proclamation comes into operation on the day on which it is made.

#### **3**—Alteration of title of body corporate

The title of the body corporate constituted under section 7(1) of the *Administrative Arrangements Act 1994* as the Minister for Trade, Tourism and Investment is altered to the Minister for Trade and Investment.

#### 4—Transfer of assets and interpretive provision

- (1) The assets, rights and liabilities of the body corporate formerly known as the Minister for Trade, Tourism and Investment related to the administration of the following Acts are transferred to the Premier:
  - (a) Major Events Act 2013;
  - (b) South Australian Motor Sport Act 1984;
  - (c) South Australian Tourism Commission Act 1993.
- (2) A reference to the Minister for Trade, Tourism and Investment in an instrument or contract, agreement or other document made or entered into under or in connection with an Act referred to in subclause (1) before the commencement of this proclamation will have effect as if it were a reference to the Premier.

#### 1—Short title

This proclamation may be cited as the *Administrative Arrangements (Committal of Acts) Proclamation 2020.* 

#### 2—Commencement

This proclamation comes into operation on the day on which it is made.

#### 3—Committal of Acts

The administration of an Act referred to in Schedule 1 is committed to the Premier.

#### 1—Short title

This proclamation may be cited as the Administrative Arrangements (References to Department for Trade, Tourism and Investment) Proclamation 2020.

#### 2—Commencement

This proclamation comes into operation on the day on which it is made.

#### **3**—Interpretive provisions

- (1) A reference to the Department for Trade, Tourism and Investment in an instrument or contract, agreement or other document made or entered into under or in connection with an Act referred to in Schedule 1 before the commencement of this proclamation will have effect as if it were a reference to the Department of the Premier and Cabinet.
- (2) A reference to the Chief Executive of the Department for Trade, Tourism and Investment in an instrument or contract, agreement or other document made or entered into under or in connection with an Act referred to in Schedule 1 before the commencement of this proclamation will have effect as if it were a reference to the Chief Executive of the Department of the Premier and Cabinet.

## Part 1—Preliminary

#### 1—Short title

These regulations may be cited as the *Controlled Substances (Poisons) (Emergency Supplies) Variation Regulations 2020.* 

#### 2—Commencement

These regulations come into operation on the day on which they are made.

#### **3**—Variation provisions

In these regulations, a provision under a heading referring to the variation of specified regulations varies the regulations so specified.

## Part 2—Variation of Controlled Substances (Poisons) Regulations 2011

#### 4—Variation of regulation 21—Exemptions from section 18 of Act

- (1) Regulation 21(2)(f)(ii)—delete subparagraph (ii) and substitute:
  - (ii) sells or supplies—
    - (A) where the pharmacist is satisfied that the person for whom it is to be sold or supplied is affected by an emergency specified by the Minister by notice under subregulation (2a) and the sale or supply occurs during the period specified in relation to that emergency in the same notice—
      - for drugs that are on the Pharmaceutical Benefits Scheme—no more than the standard Pharmaceutical Benefits maximum quantity; or

- for drugs that are not on the Pharmaceutical Benefits Scheme—the quantity that is contained in the smallest standard pack in which the drug is generally available; or
- (B) in any other case—
  - if the drug is a cream, ointment or liquid or one that is packaged in such a manner as to promote the safe and proper use of the drug—the smallest standard package or container made by the manufacturer; or
  - if the drug is not a cream, ointment or liquid or other drug described above—no more than 3 days dosage of the drug; and
- (2) Regulation 21—after subregulation (2) insert:
  - (2a) If the Minister is satisfied that an emergency (within the meaning of the *Emergency Management Act 2004*) is occurring in an area of the State, the Minister may, by notice in the Gazette, specify the emergency and a period of time in relation to that emergency for the purposes of subregulation (2)(f)(ii)(A).
  - (2b) A notice under subregulation (2a)—
    - (a) may specify the emergency by reference to any factor the Minister thinks fit (including, without limitation, by a description of the circumstances of the emergency, the area within which the emergency is occurring or by any description by which the emergency is commonly known); and
    - (b) may, from time to time as the Minister thinks fit, be varied or substituted by a new notice or be revoked.
- (3) Regulation 21—after regulation (3) insert:
  - (4) In this regulation—

*Pharmaceutical Benefits Scheme* means the Pharmaceutical Benefits Scheme under the National Health Act.

As required by section 10AA(2) of the *Subordinate Legislation Act 1978*, the Minister has certified that, in the Minister's opinion, it is necessary or appropriate that these regulations come into operation as set out in these regulations.

CONTROLLED SUBSTANCES (POISONS) REGULATIONS 2011

## **Controlled Substances (Poisons) (Emergency Supply)** Notice 2020

under regulation 21 of the Controlled Substances (Poisons) Regulations 2011

#### 1—Short title

This notice may be cited as the *Controlled Substances (Poisons) (Emergency Supply) Notice 2020.* 

#### 2—Commencement

This notice comes into operation on the day on which it is made.

#### **3**—Declaration of period and area

For the purposes of regulation 21(2)(f)(ii)(A) of the *Controlled Substances (Poisons) Regulations 2011* I specify—

- (a) the emergency consisting of the fires occurring on Kangaroo Island during December 2019 and January 2020; and
- (b) the period ending on 31 March 2020 in relation to that emergency.
