GENERAL AUTHORITY FOR THE IMPORTATION OF USED HORSE EQUIPMENT

I, RODERICK ANDREWARTHA, Chief Veterinary Officer, hereby issue a General Authority for the importation of fittings used in connection with horses, donkeys, mules or other animals of the family Equidae.

The following conditions will apply:

- The fittings must not have been on any property that is known or suspected to be infected with equine influenza within the 7 day period prior to entry into Tasmania
- 2. The fitting must be accompanied on arrival in Tasmania by a declaration by the consignor that the fittings have not been on any property that is known or suspected to be infected with equine influenza within the 7 day period prior to entry into Tasmania.

ANIMAL HEALTH ACT 1995

Section 18

GENERAL AUTHORITY FOR THE IMPORTATION OF HORSES, DONKEYS AND MULES

I, RODERICK ANDREWARTHA, Chief Veterinary Officer, hereby issue a General Authority for the importation of horses, donkeys and mules into Tasmania.

The following conditions will apply:

- 1. The horses, donkeys or mules must not be known or suspected to be infected with equine influenza.
- Within the 14 days prior to arrival in Tasmania the horses, donkeys or mules must not have been in an area in New South Wales or Queensland that is declared as a Restricted Area with respect to equine influenza
- 3. The horses, donkeys or mules must be accompanied on arrival in Tasmania by a declaration by the consignor that the horses, donkeys or mules have not been in an area in New South Wales or Queensland that is declared as a Restricted Area with respect to equine influenza, within 14 days prior to arrival in Tasmania.

The declaration must also:

- (a) Provide a description of the horses, donkeys or mules; and
- (b) Provide details of the property of origin of the horses, donkeys or mules; and
- (c) Provide details of the property of destination of the horses, donkeys or mules.
- 4. If the horses, donkeys or mules have been in New South Wales, Queensland or the Australian Capital Territory within the 14 days prior days prior to arrival in Tasmania, and have transited through Victoria, either:
 - (a) a copy of the Victorian Horse Entry Declaration applying to the entry of the horses, donkeys or mules into Victoria is to be attached to the declaration by consignor described in clause 3, or
 - (b) a copy of a certificate signed by a person authorise by the Chief Veterinary Officer of Victoria that the horses, donkeys or mules have completed requirements for entry into Victoria is to be attached to the declaration by consignor described in clause 3.

GENERAL AUTHORITY FOR THE IMPORTATION OF HORSE SEMEN

- 2. The horse semen must be accompanied on arrival in Tasmania by a declaration by the consignor that the property where the horse semen was collected was not known or suspected to be infected with equine influenza

Living Marine Resources

FISHERIES (BIOSECURITY) ORDER 2008

I MAKE the following Order under section 270 of the *Living Marine Resources Management Act 1995* issuing directions aimed at preventing the introduction into State waters of a harmful disease.

Short title

1.—This order may be cited as the Fisheries (Biosecurity) Order 2008.

Specification

2.—This Order is made in respect of the disease Abalone Viral Ganglioneuritis and aimed at preventing the introduction of the disease into State waters.

Directions Issued

- **3.**—(1) That unless otherwise authorised under Rule 62 of the *Fisheries (Rock Lobster) Rules 2006*, all abalone and rock lobster taken in State waters must be landed in Tasmania.
- (2) That, unless otherwise authorised in writing by the Secretary, no abalone or rock lobster taken, other than under the authority of a Tasmanian commercial fishing licence, may be transported in State waters north of the line of Latitude 39° 30' South in a vessel other than a vessel operated by the TT Line Company Pty Ltd.

- (3) That all abalone taken under the authority of a Tasmanian commercial fishing licence from State waters adjacent to King Island bounded by the line of latitude 40° 20° 00° South in the south, the line of longitude 143° 30° 00° East in the west, the line of latitude 39° 30° 00° South in the north and the line of longitude 144° 30° 00° East in the east must be landed on King Island
- (4) That no abalone taken from waters as described in (3) above may be processed in premises on the Tasmanian mainland that discharge effluent directly into the marine environment

Interpretation

4.—Expressions in this order have the same meaning as in the *Living Marine Resources Management Act 1995* and the *Fisheries (Abalone) Rules 2000.*
